Mayor Scott P. Strauss stated that he, Benjamin Truncale, Esq., and Village Clerk Joseph R. Scalero attended a meeting with the Town of North Hempstead regarding the Bruce Terrace Flood Mitigation project and presented an update on that project, commented that plans are being made to paint the Community Center and the large American Flag has been taken down and will be put back up after painting is completed. Mayor Strauss condemned the graffiti incident that occurred during the weekend of February 10, 2012, stating that the Village of Mineola will prosecute anyone found to be involved in these crimes and announced that a reward is in place for any information leading to the arrest and conviction of those involved. Residents can call 1-800-244-TIPS if they have any information.

Trustee Lawrence A. Werther also commented on the graffiti incident, congratulated Gary Tuthill on his promotion, and commented that due to the current New York State redistricting plan the Village of Mineola will lose the services of one of our State Assemblymembers, Tom McKeivitt. Trustee Werther added that a smaller portion of the Village of Mineola will be represented by State Assemblywoman Michele Schimel and recommended residents write to the Assembly Speaker Sheldon Silver to voice their concerns. Trustee Werther thanked Senator Jack M. Martins on sponsoring two pieces of legislation that will benefit Mineola, the first to exempt villages from the MTA payroll tax, and the second to allow villages to use lever voting machines in village elections.

Trustee Paul S. Cusato thanked the Kiwanis Club for the great job organizing their annual Pancake Breakfast; reminded residents to support the St. Patrick's

Day Parade on Sunday, March 4, 2012, and encouraged residents to support the Mineola Junior Fire Department's Annual Pasta Dinner on Sunday, March 11, 2012 from 12:00 PM - 5:00 PM.

Trustee Paul A. Pereira denounced the recent graffiti incident and thanked Superintendent of Public Works Thomas J. Rini, Chaminade High School, and others who responded so quickly to remove the graffiti. Trustee Pereira encouraged residents to come out and enjoy the St. Patrick's Day Parade and support those marching.

Trustee George R. Durham echoed the remarks of Mayor Scott P. Strauss and fellow trustees regarding the graffiti incident and encouraged anyone who knows or saw something to call the TIPS line. Trustee Durham announced that he attended Boy Scouts Pack 246's Blue & Gold dinner with Mayor Scott P. Strauss and Senator Jack M. Martins; attended and enjoyed the Kiwanis Pancake Breakfast and encouraged residents to march in or support the St. Patrick's Day Parade and the Mineola Junior Fire Department's Pasta Dinner.
