NOTICE

Permits under Village of Mineola Resolution No. R-95-404 Section 60.2(B) of the Code of the Incorporated Village of Mineola may be issued only to residents of the Village of Mineola. The parking permit must be permanently affixed to the exterior rear passenger window on the driver's side of vehicle. **This permit is valid only while you reside in Mineola and the vehicle is registered to a Mineola address and used on the vehicle with license number on your application.** Vehicle license plate number must match number on permit.

If you wish to transfer this permit to another vehicle, the Parking Permit must be returned and a replacement fee of \$10.00 will apply.

INCORPORATED VILLAGE OF MINEOLA COMMUTER PARKING FIELDS

Please note that the following fields are the ONLY fields designated for use with Commuter Parking Permits.

Commuter Parking Permits are not valid in any other village parking fields or on-street parking.

Vehicles displaying valid Commuter Parking Permits parked in any space outside designated commuter parking spaces are subject to posted parking regulations.

PARKING FIELD 1

Lot at west side of Third Avenue, east of NYU Winthrop Hospital

PARKING FIELD 3 – 200 OLD COUNTRY ROAD

Parking garage on Third Street, east of Mineola Boulevard

Ground Level, Level One, and connecting ramp only

PARKING FIELD 7

North side of LIRR, south of Field 1 (adjacent to LIRR tracks)

STATION ROAD

Station Road on the north and south side of street, between 5th Avenue and 8th Avenue
