The New York State Department of Public Service (DPS or Department) is seeking comment on PSEG Long Island's (PSEG LI) 2020 Energy Efficiency and Renewables Plan (Plan). On August 1, 2019, in accordance with the Long Island Power Authority Reform Act (LRA), PSEG LI submitted the Plan to the DPS for review and recommendation. Pursuant to the LRA, the purpose of the Plan is to implement energy efficiency measures, distributed generation, or advanced grid technology programs providing customers with tools to more efficiently and effectively manage their energy usage and utility bills, and improve system reliability and power quality.<sup>1</sup>

Interested persons or parties are invited to submit comments on the Plan by September 30, 2019. Reply comments are requested by October 15, 2019. The Plan may be viewed, printed or downloaded from the Department's Web site at <http://www.dps.ny.gov> by searching for Matter Number 19-01859.
