**PLEASE TAKE NOTICE** that the Board of Trustees of the Incorporated Village of Mineola will hold a Public Hearing on Wednesday, April 10, 2013 at 6:30 p.m., at the Village Hall, 155 Washington Avenue, Mineola, New York 11501, or at some other location to be hereafter designated by the Board of Trustees, in order to receive public comment upon the following:

**A PROPOSED LOCAL LAW  
AUTHORIZING A PROPERTY TAX LEVY IN EXCESS OF  
THE LIMIT ESTABLISHED IN GENERAL MUNICIPAL  
LAW §3-C. THIS LOCAL LAW WILL NOT REQUIRE THE  
MUNICIPALITY TO AUTHORIZE A PROPERTY TAX  
LEVY IN EXCESS OF THE LIMIT ESTABLISHED IN  
GENERAL MUNICIPAL LAW §3-C, BUT HAS BEEN  
RECOMMENDED FOR ADOPTION BY THE NEW YORK  
CONFERENCE OF MAYORS TO PROTECT THE  
MUNICIPALITY IF THERE IS A TECHNICAL OR  
CLERICAL ERROR IN THE CAP CALCULATION OR  
SOME OTHER UNFORESEEN OCCURRENCE THAT  
RESULTS IN A MUNICIPALITY INADVERTENTLY  
EXCEEDING THE TAX CAP.**
