Mayor Scott P. Strauss stated that he had the honor of presenting certificates at the WARM Association of Girl Scouts' annual Bronze, Silver, and Gold Award celebration noting that there were numerous Bronze awards, fewer in Silver and only one Gold Award, which was given to Emma Parente and he congratulated all recipients. Mayor Strauss reported on the Vision Long Island Smart Growth Summit in which he and Village Clerk Joseph Scalero participated in. Mayor Strauss reminded residents to shop locally for the holiday season, and reminded residents and businesses that snow season is here, urging them to sign up for E-Notices on the Village of Mineola website, and to obey the snow ordinance when 2 or more inches of snow falls. Mayor Strauss also reminded residents of the Tree Lighting Ceremony December 5 at 7:00 PM and encouraged everyone to come and enjoy this seasonal event.

Trustee Paul A. Pereira wished everyone a Merry Christmas and a Happy Holiday season, reminded residents of the annual Tree Lighting ceremony, reported on the attendance of the Board of Trustees at the Winthrop University Hospital Tree Lighting ceremony commending the Mineola High School concert singers not only for their performance, but for their community service by going through the hospital caroling, bringing some holiday spirit to patients. Trustee Pereira recognized John DaVanzo's birthday commenting that this is the first year he is not here with us and extended the thoughts and prayers of the Board to the DaVanzo family.

Trustee Paul S. Cusato reminded residents that the Toy-for-Tots program is operating until December 15; announced the Mineola Fire Department's "Operation Santa" is back in operation and encouraged residents with children to contact the Mineola Fire Department to set-up a visit from Santa. Trustee Cusato reported on the Mineola School Board meeting being placed on YouTube commenting that there were a great many inaccuracies put forth and that this was upsetting and the record needs to be set straight.

Trustee George R. Durham concurred with Trustees Cusato's comments on the Mineola School Board meeting; reported that the Winthrop University Hospital Tree Lighting was a wonderful event; wished residents a happy Chanukah; and announced that the Mineola Athletic Association (MAA) registration is now open.

Trustee Dennis Walsh commented that the Winthrop University Hospital Tree Lighting was a nice affair and commended the Mineola High School singers on their performance. Trustee Walsh expressed his disappointment at the comments made by Mineola School Board President Barnett regarding police, stating that there was no purpose served by his commentary and that there is no place in Mineola for such speech.

Mayor Scott P. Strauss spoke out regarding the recent commentary by the Mineola School Board regarding development projects in the Village of Mineola. Mayor Strauss explained that the involvement of the Nassau County IDA and the resulting PILOTS are governed by New York State law and not by villages. Mayor Strauss continued by refuting on a point-by-point basis each

of the Mineola School Board inaccuracies and reiterated that there is no animosity toward the Mineola School Board on the part of the Board of Trustees, but rather a desire to work together for the benefit of Village of Mineola residents.
