*A Public Hearing was held 6:45 PM at the Village Hall, 155 Washington Avenue, Mineola, New York, 11501 in order to receive public comment upon the following:*

**PROPOSED LOCAL LAW AMENDING CHAPTER 523 OF THE MUNICIPAL CODE OF THE INCORPORATED VILLAGE OF MINEOLA, ENTITLED “WATER” SECTION 523-28, ENTITLED “WATER RATES; FEES”, SO AS TO PROVIDE FOR A NEW SCHEDULE OF RATES BASED UPON THE SIZE OF THE METERS, TO ADJUST THE RATES FOR WATER SUPPLIED AT CONSTRUCTION SITES, TO ADJUST THE RATES FOR AUTOMATIC SPRINKLER SYSTEMS, TO ADJUST THE RATES FOR MISCELLANEOUS WATER USAGE AND FOR NON-PROFIT ORGANIZATIONS, AND TO ADJUST THE RATE SCHEDULE FOR MONTHLY AND SEMI-ANNUAL WATER BILLING BASED UPON CONSUMPTION LEVELS.**

*Village Attorney John M. Spellman and Superintendent of Public Works Thomas J. Rini presented the details of this proposed Local Law explaining the following:*

- A) Construction usage is not adequately charged based on the actual cost to produce water used during construction*
- B) Miscellaneous water usage is no longer being charged an appropriate rate given the actual cost to produce water and recommended the following resolutions:*
