**DECISION:**

Jeremiah O'Carroll (hereinafter, "Applicant") is before this Board pursuant to Chapter 550, Section 550.12.B of the Municipal Code of the Incorporated Village of Mineola for a special use permit to expand an existing restaurant/tavern into the rear portion of an adjoining building and establish a carry-out establishment (nutrition health shake store) in the remaining portion of the adjoining building upon the property known as 212 Station Plaza, Mineola, New York (known and designated on the Nassau County Land and Tax Map as Section 9, Block 422, Lot 111) (hereinafter, the "Property").

By Notice of Disapproval, dated September 30, 2013, Applicant's building permit was denied. The Building Inspector determined that the proposed application is contrary to the Village's zoning regulations in that the expansion of an existing restaurant/tavern into the rear portion of an adjoining building and establishment of a carry-out establishment (nutrition health shake store) in the remaining portion of the adjoining building upon the Property requires a special use permit. Applicant was thus required to seek relief before the Board of Trustees for a special use permit.

A referral of the application was made to the Nassau County Planning Commission on November 21, 2013. By letter, dated November 27, 2013, the Nassau County Planning Commission has recommended that this Board take whatever action it deems appropriate. Based upon the evidence adduced at the public hearing, and the documentation submitted to the Board in support of the application, the Board makes the following findings of fact:

- 1) Applicant is seeking a special use permit to expand an existing restaurant/tavern into the rear portion of an adjoining building and establish a carry-out establishment (nutrition health shake store) in the remaining portion of the adjoining building upon the property known as 212 Station Plaza, Mineola, New York;
- 2) Applicant owns the building located at 212 Station Plaza, Mineola, New York;
- 3) Applicant owns the business (O'Carroll's Recovery Room) and leases the space located at 210 Station Plaza, Mineola, New York;
- 4) Applicant proposes to utilize the front of the building for nutritional health shakes and the rear of the building for bar use;

The Property is located in the Village of Mineola's B-2 Business District. Section 550-13 of the Municipal Code of the Incorporated Village of Mineola governs the uses in the B-2 Business District which permits "[a]ny use permitted in the B-1 District as of right or any use permitted in the B-1 District as a special use...." Pursuant to Section 550-12.B, the B-1 District permits as a special use, inter alia, restaurants, taverns and carry-out food establishments. Restaurant is defined

as a “food-service establishment in which at least 60% of gross revenue is derived from seated patrons who dine on premises inside the building occupied with waiter/waitress service.” (See Section 550-12.B(1)). A carry-out food establishment is defined as a “food-service establishment in which less than 60% of gross revenue is derived from seated patrons who dine on premises inside the building occupied with waiter/waitress service.” (See Section 550-12.B(4)).

Thus, before the Board of Trustees is a determination as to whether a restaurant use is appropriate at the Property, whether a carry-out food establishment is appropriate at the Property and whether a combination of both uses is appropriate there.

The site is on the north side of Station Plaza, between 3<sup>rd</sup> Avenue and Mineola Boulevard Extension.

Station Plaza is a central transportation hub in Mineola. It abuts the Mineola Long Island Rail Road station to the south. Servicing the main line of the railroad, the station has twenty three (23) train departures daily between the hours of 6:30 a.m. and 10:00 a.m. The Village’s Comprehensive Master Plan chronicled that 2,700 commuters utilized the Mineola Station daily in 2005. That number has risen since that time.

Station Plaza experiences significant rush hour traffic in the morning when “kiss and ride” commuters are dropped off for their trains. Numerous taxicabs and shuttle buses also contribute to massive congestion. Furthermore, Station Plaza is the truck route for all deliveries to Winthrop University Hospital which is located to the immediate west of the Property.

On the north side of Station Plaza are a number of retail establishments: two convenience/stationery stores, a restaurant/coffee shop and the restaurant/tavern of the Applicant. Deliveries to all of these establishments are made via Station Plaza. The MTA/LIRR also parks service vehicles in the Plaza.

In a word, Station Plaza is a highly-congested but strategically important traffic circulation route in Mineola, especially during peak railroad travel hours. Preserving and promoting safe passage through this challenging vehicular gauntlet is a major objective of the Village.

Based upon the record, upon research conducted by the Village in formulating its Comprehensive Master Plan, and upon its own keen knowledge of and familiarity with Station Plaza, the Board finds that the proposed carry-out food establishment will have a negative impact on the health, safety and welfare of the community. Although no parking or traffic study has been introduced into the record, Applicant’s proposed carry-out food establishment will undoubtedly

increase the number of vehicles attempting to access and park in an area that is already fully congested and woefully deficient as to parking. The area is serviced by pull-in/pull-out metered spaces, the utilization of which routinely blocks traffic flow. Parking restrictions in the area will require patrons to park in unpermitted areas or even double-park. Such a situation would be detrimental to the traffic circulation of the area and would be unsafe. Applicant is unable to provide any off-street parking whatsoever either at the site or elsewhere.

While the Board finds that the establishment of a take-out food establishment at the Property would be contrary to the health, safety and welfare of the Village, it has no objection to the expansion of the existing restaurant/tavern into a portion of the Property or even into the entire Property. The distinction in the Village's Municipal Code between a restaurant and a carry-out food establishment is made for a reason. Patrons of a restaurant generally park their vehicles for a period of time, enter the restaurant and enjoy their meals while dining. It is perceived as reasonable for them to park their vehicles even a distance from the restaurant. Patrons of a take-out food establishment, on the other hand, are ordinarily on-the-run. Their goal is to park their vehicles as close to the site as possible, secure their purchases and get on with their lives. The two types of establishments have totally different impacts upon parking and traffic.

Based upon the entire record and the reasons set forth above, the Board finds the approval of this application for a take-out food establishment at the Property would not be in the best interest of the health, safety and welfare of the community. The proposed use consists of an over-intensification of land use, a mixture of incompatible uses and a recipe for conflict with the traffic circulation of the area. The Board concludes that the Applicant has failed to meet its burden with regard to the legality and propriety of the proposed application for a take-out food establishment. Accordingly, this portion of the application is DENIED.

With respect to the application for expansion of the adjacent restaurant/tavern into the Property, that application is GRANTED. Additionally, if the Applicant so desires, he may utilize the entire space at the Property for the expansion of the existing restaurant/tavern.

Mayor Scott P.
