**DECISION:**

Wing H. Law (hereinafter, “Applicant”) is before this Board pursuant to Chapter 550, Section 550.12.B of the Municipal Code of the Incorporated Village of Mineola for a special use permit to establish a used car sales, auto repair and hand car wash and detailing shop upon the property known as 70 East Jericho Turnpike, Mineola, New York (known and designated on the Nassau County Land and Tax Map as Section 9, Block 366, Lot 93) (hereinafter, the “Property”).

By Notice of Disapproval, dated October 24, 2013, Applicant’s building permit was denied. The Building Inspector determined that the proposed application is contrary to the Village’s zoning regulations in that the establishment of a used car sales, auto repair and hand car wash and detailing shop upon the Property requires a special use permit. Applicant was thus required to seek relief before the Board of Trustees for a special use permit.

A referral of the application was made to the Nassau County Planning Commission on November 21, 2013. By letter, dated November 27, 2013, the Nassau County Planning Commission has recommended that this Board take whatever action it deems appropriate. Based upon the evidence adduced at the public hearing, and the documentation submitted to the Board in support of the application, the Board makes the following findings of fact:

- 1) Applicant is seeking a special use permit to establish a used car sales, auto repair and hand car wash and detailing shop upon the property known as 70 East Jericho Turnpike, Mineola, New York;
- 2) Applicant would lease the property from current property owner;
- 3) Applicant operates another auto business, Cross Country Auto, located at 135-07 38<sup>th</sup> Avenue, Flushing, New York;
- 4) Applicant proposes to store twenty (20) vehicles on the Property;
- 5) Applicant proposes to service vehicles on the Property;

- 6) Applicant proposes to operate a hand car wash and detailing on the Property;
- 7) Applicant proposes to operate a mobile food truck on the Property;
- 8) Applicant does not currently have a mobile food license from Nassau County;
- 9) Applicant does not currently have a mobile food license from the Village of Mineola;
- 10) Applicant does not currently have a mobile food truck registered with the New York State DMV;
- 11) Applicant does not currently have a retail car dealer license from New York State;

During the public hearing, Applicant made statements which were in stark contrast to the original application submitted for this Board's consideration and to the above-referenced representations.

- 1) Applicant was asked whether the office space attached the garage bays was large enough for a used car dealer to interact with buyers and sellers, as well as, provide a waiting room for people having their cars serviced. Applicant stated it was small and wanted "permission to add another, like a trailer." Applicant did not supply any plans, drawings or details with respect to size and location of the proposed office trailer;
- 2) Applicant was asked whether he had a traffic flow plan/pattern for the proposed uses at the Property. Applicant was asked whether he had a parking plan for the proposed storage of vehicles at the Property. Applicant did not supply the Board with any plans or drawings. Rather, Applicant used a blank piece of paper in an attempt to orient the Board to the Property and the proposed uses, but did not make any markings or inscriptions upon the paper. As a result, if there was a plan, it was incomprehensible.
- 3) Applicant was asked about how he would address the water runoff from the hand car wash, Applicant was unaware of any regulations/requirements and stated that he would need to "find out."
- 4) The Application sought approval for a mobile food trailer. Applicant stated that it would be selling coffee, light breakfast and some refreshments. Applicant then indicated that he would be doing cooking in the trailer and would be serving lunch.
- 5) When asked about the number of employees at the Property, Applicant was unclear as to the number of employees and location of employee parking.
- 6) Mr. Ralph Sansone, Owner of the Property, appeared at the Public Hearing and categorized the Application as "completely overreaching." Mr. Sansone stated he was

“a little bit in shock.” He believed the special permit was for a wholesale/retail car lot. He stated the Applicant is “saying 20 cars. I don’t know how he’s going to work it out.” There is thus a question as to whether there is a continued consent by the owner of this property to this application as presented.

Based upon the entire record, the Board finds several inconsistencies with this application and that it is incomplete on its face. The Board is particularly concerned about the many vague and at times contradictory statements made by and on behalf of the Applicant on the record. Furthermore, the Board is doubtful about the legitimacy of the proposed operation in light of the vague and contradictory testimony given at the hearing.

The approval of this application would not be in the best interest of the health, safety and welfare of the community. The Application consists of an over-intensification of land use, a mixture of incompatible uses and a recipe for conflict with neighboring properties. The Board concludes that the Applicant has failed to meet its burden with regard to the legality and propriety of the proposed application.

**IT IS THEREFORE RESOLVED**, that the special use permit is **DENIED**.

Mayor Scott P.
