Mayor Scott P. Strauss presented a Citation from the office of County Executive Ed Mangano to Bill Urianek in recognition of his significant contributions to the betterment of our residents and, in particular, his efforts to assist our war veterans.

Mayor Scott P. Strauss reported on Senior Appreciation Day thanking those that made it possible; the Mineola Junior Fire Department Benefit Pancake fundraising for the victims of the typhoon in the Philippines on December 1, commenting how successful it was; and reminded residents of the annual Tree Lighting Ceremony on December 6 at 7:00 PM. Mayor Strauss thanked Superintendent of Public Works Tom Rini and his staff for the Holiday lights throughout the village; stated that Mineola Fire Department “Operation Santa” program is now officially started, and encouraged residents with children to call 746-6583 to set-up a visit from Santa. Mayor Strauss reminded residents to sign up for e-mail and text notifications on the village website and to remember that cars need to be removed from village streets in the event of two or more inches of snow to avoid being ticketed.

Trustee Paul A. Pereira commented that the Mineola Junior Fire Department fundraising breakfast for the victims of the typhoon in the Pillippines was very impressive and successful. Trustee Pereira encouraged residents to come to the annual village tree lighting ceremony on December 6 at 7:00 PM and wished everyone a happy holiday.

Trustee Paul S. Cusato stated that the Mineola Junior Fire Department fundraising breakfast was a great event and reminded residents that the “Toys for Tots” program has started with collection boxes at four locations – Village Hall, Mineola Fire Department Headquarters, Mineola Fire Department at Elm Place and Mineola Memorial Library and encouraged residents to particiate in this program. Trustee Cusato requested residents with children to call for “Operation Santa” to visit them.

Trustee George R. Durham reported on Senior Appreciation Day thanking the Mineola businesses that donated to this event making it a nice day for our seniors; on the Winthrop University Hospital’s tree lighting; and on the Junior Fire Department fundraising benefit breakfast. Trustee Durham mentioned that the Mineola Choral Society and Nassau Pops will be at Chaminade High School on December 15 for a Christmas Concert and encouraged residents to attend.

Trustee Dennis J. Walsh commented on Senior Appreciation Day and thanked those involved for making it such a success. Trustee Walsh reflected on the Mineola Master Plan and how it’s coming into play with the various different projects that are underway and how these projects interact with and affect future projects within the village.
