WHEREAS, the Village of Mineola considers the property to be necessary for local municipal use; and

WHEREAS, taxpayers in the Village of Mineola have supported the property since its acquisition by exempting it from local taxes, and its transfer to local ownership will remove management burden on the State of New York; and

WHEREAS, conveyance of this state-owned land to the Village would be consistent with conditions agreed to and originally made part of the Roslyn and Mineola Grade Cross Elimination projects; and

WHEREAS, transfer of the land would be consistent with the NYSDOT policies allowing transfer of public properties between government entities for a one dollar cost, providing the parcel is used for non-profit purposes that benefit the general public; and

WHEREAS, this action is classified Type II pursuant to SEQRA 6 NYCRR 617.5(c)(21) as it is part of the preliminary planning process necessary for the formulation of a plan for action, and shall only follow a Village Board SEQRA review prior to property acceptance;

NOW, THEREFORE, BE IT

MEMORIALIZED, that the Village Board requests the State of New York Department of Transportation convey the properties identified in the above table, and

BE IT FURTHER

Mayor Scott P. Strauss presented pins to the firefighters of Mineola Fire Department Company 1 in recognition of their dedicated service to the community for the past 125 years.

Mayor Scott P. Strauss reported on the Evening Star Quilters' Show, on the Chamber of Commerce "Taste & Style of Mineola", and on the Mineola Memorial Library's presentation of the 150th Anniversary Commemoration of the Gettysburg Address, commenting how successful these events were; thanked the owners of 250 Old Country Road for allowing the Mineola Fire Department to conduct multi-department fire drill exercises at that location before it is demolished; and reminded residents of the annual Tree Lighting Ceremony on December 6 at 7:00 PM. Mayor Strauss announced that American Express in conjunction with Patch.com will host "Park on Patch" on Small Business Saturday, November 30, which will offer free meter parking on Jericho Turnpike and encouraged residents to come and support Mineola businesses. Mayor Strauss mentioned that residents can now receive text notifications as well as email notifications and reminded residents to sign-up for these features on our website. Trustee Paul A. Pereira reported on the Mineola Knights of Columbus 90th anniversary celebration, congratulating them; and stated that he attended a commemoration of the 75th anniversary of Kristallnacht at Touro Law School November 12. Trustee Pereira reminded seniors of the Senior Appreciation Luncheon November 25, the Tree Lighting Ceremony December 6 at 7:00 pm and Small Business shopping November 30 requesting residents to shop locally and support our local businesses. Trustee Pereira wished a Happy Thanksgiving and Happy Hanukkah to all residents.

Trustee Paul S. Cusato commented on the incredible talent of those quilters displaying their work at the Evening Star Quilters' Show; stated that the "Taste & Style of Mineola" was a great event and announced that "Toys for Tots" holiday toy collection will start Monday December 2 at four locations - Village Hall, Mineola Fire Department Headquarters, Mineola Fire Department at Elm Place and at the Mineola Memorial Library.
