Mayor Scott P. Strauss reported that the 9/11 Remembrance Ceremony was well attended and thanked those who worked on it; commended the Mineola Chamber of Commerce on the Mineola Street Fair and recognized their efforts in organizing this successful event, and thanked the Department of Public Works staff and the Mineola Auxiliary Police for their contributions to the success of the event. Mayor Strauss reported on the Mineola High School Homecoming Parade, the Mineola Bicycle Safety Day program, the opening of Emory Road Park, and a meeting of Village Officials with the New York State Department of Transportation to discuss street lighting, parking, and the timing of traffic signals. Mayor Strauss announced that there would be a Public Hearing October 9 at 6:30 PM at Village Hall regarding a proposed gas station and convenience store at 449 Jericho Turnpike and encouraged residents to attend. Mayor Strauss reminded all residents of the Mineola Halloween Party October 25 from 7:00 PM – 9:00 PM.

Trustee Paul A. Pereira reminded residents that on November 19 at 12:00 noon there will be a re-enactment of the Gettysburg Address at the Mineola Memorial Library, and encouraged residents to attend the Friday night Mineola High School home football game on October 4.

Trustee Paul S. Cusato thanked residents for their support of the 9/11 Remembrance Ceremony and the Mineola Chamber of Commerce for their efforts in organizing the Mineola Street Fair. Trustee Cusato reported on the Mineola Historical Society’s efforts to identify some of the older pictures in their collection.

Trustee George R. Durham thanked residents for their support in commemorating the events of 9/11 and announced that Boy Scouts of America Troop 45 is beginning its annual fundraising campaign with the sale of Christmas wreaths and encouraged residents to support the scouts.

Trustee Dennis J. Walsh announced that the Nassau County Bar Association will be holding a “Pro Bono” legal fair at their association headquarters on Thursday October 24 between 3:00 PM and 6:30 PM. Trustee Walsh announced that the Mineola Portuguese Heritage Society will host a “Big Style Buffet” breakfast October 13 from 8:30 AM – 11:30 AM to assist Corpus Christi with a fundraising effort on. Trustee Walsh stated that he attended a workshop organized by Senator Jack Martins to inform parents of special needs children of specific legal opportunities and responsibilities, commenting that it was very informative and that anyone with questions should contact the Senator’s office. Trustee Walsh reported on a visit to the Fire Training Academy with the Mineola Fire Department and Mayor Strauss stating that it was an impressive demonstration of the equipment, but more importantly of the risks our firemen take to protect us.
