Mayor Scott P. Strauss announced that Sunday May 18 the Kiwanis Club and Mineola Bicycle are sponsoring a Bicycle Safety Day at Jericho Turnpike and Beebe Road from Noon – 3:00 PM; on Monday May 27 the Memorial Day parade will start at 11:00 AM at Wilson Field and will proceed to Memorial Park where there will be a ceremony honoring our veterans. Mayor Strauss stated that through the efforts of Nassau County Legislator Richard Nicoletto the county portion of the Bruce Terrace Flood Mitigation project on Sheridan Boulevard has finally been approved by Nassau Interim Finance Authority (NIFA) and should progress rapidly at this point.

Trustee Paul A. Pereira reported on the Nassau County Hub meeting which he and several Trustees attended; reminded residents of the “Night on the Town” at Jericho Terrace on May 22; the Memorial Day Parade on May 27; the Mineola Athletic Association’s “Fun Day” on June 1 at the Little League fields; and the Mineola Portuguese Center’s Annual Carnival at Wilson Field on June 7 through June 9.

Cusato reported that he attended the Nassau County Hub meeting; attended the Nassau County Firefighter Memorial service and thanked the Island Park Fire Department for hosting the event; and announced that the Mineola Fire Department is in the final stages of their fund drive. Durham reported that he and Trustee Walsh attended the New York Conference of Mayors (NYCOM) conference for Village Officials; reminded residents of the Mineola Athletic Association playoffs starting on May 23 for the Majors and June 9 for the minors and encouraged residents to attend.
