Mayor Scott P. Strauss reported on the Mineola Athletic Association (MAA) Opening Day Parade, congratulating all the recipients of the Mayor’s Trophy Awards and thanked Superintendent of Public Works Thomas J. Rini and staff for getting the fields prepared for the season. Mayor Strauss reported that he attended the Nassau County Village Officials Association (NCVOA) meeting with Trustees’ Durham and Walsh; attended a presentation of the Mineola Historical Society at the Mineola Library with Trustee Cusato; and spoke briefly at both the Kiwanis Club and the Mineola Chamber of Commerce meetings. Mayor Strauss stated that he administered the Oath of Office to the newly elected and re-elected officers of the Mineola Fire Department, congratulating all of them especially Chief Jeffery Clark. Mayor Struass congratulated Jon D’Annunzio, Matt Kohl, Chis Gavin and Kevin Mulder of Boy Scouts of America Troop 45 on receiving the rank of Eagle Scout; and congratulated Janet Wohlers on receiving the Town of North Hempstead’s May Newburger Womern’s Roll of Honor. Mayor Strauss requested the cooperation of Mineola businesses in complying with Mineola’s sanitation regulations regarding placement of trash for collection particularly over weekends and stated that enforcement of those regulations would remain a priority. Mayor Strauss further stated that the New York State road resurfacing project on Jericho Turnpike has begun and requested residents to be patient and drive carefully.

Trustee Paul A. Pereira reiterated the Mayor’s comments regarding Mineola sanitation regulations and the importance of following them for residents and businesses alike. Trustee Periera congratulated the Eagle Scouts, commending them for their achievements and wished the Mineola Athletic Association (MAA) well on the start of their new season.
