#### **DECISION:**

Condeco Management Corp. (hereinafter, "Applicant") is before this Board pursuant to Chapter 30, Section 30.33 of the Municipal Code of the Incorporated Village of Mineola for a special use permit to establish a donut/coffee shop upon the property known as 47 Mineola Boulevard, Mineola, New York (known and designated on the Nassau County Land and Tax Map as Section 9, Block 428, Lot 102) (hereinafter, the "Property").

By Notice of Disapproval, dated December 10, 2012, Applicant's building permit was denied. The Building Inspector determined that the proposed application is contrary to the Village's zoning regulations in that establishing a donut/coffee shop upon the Property requires a special use permit. Applicant was thus required to seek relief before the Board of Trustees for a special use permit.

Based upon the evidence adduced at the public hearing, and the documentation submitted to the Board in support of the application, the Board makes the following findings of fact:

- 1) Applicant is seeking a special use permit to establish a donut/coffee shop upon the property known as 47 Mineola Boulevard, Mineola, New York;
- 2) Applicant shall have two (2) employees;
- 3) Applicant shall not utilize the basement space;
- 4) Applicant shall discourage its patrons from double parking;
- 5) The proposed use, subject to the conditions imposed by this Board, will provide a desirable service and convenience to the Village.

Based upon the above findings, it is hereby determined that the proposed use, subject to the conditions stated below, is harmonious to the "B-3" District, will conform to the general character of the neighborhood and that the public health, morals, safety and general welfare of such neighborhood will be secured by the granting of the requested Special Use Permit. Further, it is hereby determined that the Special Use Permit will provide a desirable facility to the area and will not be incongruous to the neighborhood by reason of excessive traffic.

IT IS THEREFORE RESOLVED that the Special Use Permit is **GRANTED** subject to the following conditions:

- 1) All putrescible waste shall be refrigerated indoors until pick-up;
- 2) The site shall be served by a private sanitation carter at the expense of the applicant. Pick up shall be on Monday, Wednesday and Friday
- 3) Deliveries to the premises shall occur during off-peak weekday hours. No deliveries to the premises shall occur between the hours of 5:00 p.m. and 7:00 a.m.;
- 4) All deliveries shall be made by Box Truck and shall be made via Third Street (not Mineola Boulevard);
- 5) Applicant shall be permitted to have a maximum of ten (10) chairs plus counter seats;
- Applicant shall provide a proper trash receptacle outside the premises in conformity with trash receptacles installed throughout the Village;
- 7) The premises shall be maintained in a clean condition at all times;
- 8) Applicant will provide a designated area for employee parking;
- 9) Each of these conditions is material to the approval granted by the Board of Trustees. Violations of any of them shall subject the applicant or it successors to enforcement pursuant to the Village's Municipal Code, including possible revocation of this special permit;
- 10) The representations made by Applicant on the record in this proceeding have been deemed material to this application and have been relied upon by

the Board of Trustees in its deliberations and decisions. Said representations are deemed to be part of the conditions of this special permit; and

Violation of a condition set forth in this decision shall be deemed a violation of the Village Zoning Law and shall subject the owner or occupant of the premises to all penalties set forth in the Zoning Law.
