**DECISION:**

Louis Palumbo (hereinafter, “Applicant”) is before this Board pursuant to Chapter 30, Section 30.31 and Section 30.51 of the Municipal Code of the Incorporated Village of Mineola for a special use permit for the operation of an auto body repair shop upon the property known as 380 Sagamore Avenue, Mineola, New York (known and designated on the Nassau County Land and Tax Map as Section 9, Block 662, Lot 1 (hereinafter, the “Property”).

By Notice of Disapproval, dated June 6, 2012, Applicant’s building permit was denied. The Building Inspector determined that the proposed application is contrary to the Village’s zoning regulations in that operating an auto body repair shop upon the Property requires a special use permit. Further, the prior property owner signed a Restrictive Covenant which runs with the land that prohibits auto body repair shops/automotive industry use upon the Property.<sup>1</sup> Applicant was thus required to seek relief before the Board of Trustees for a special use permit and cancellation/extinguishment of the Restrictive Covenant.

Based upon the evidence adduced at the public hearing, and the documentation submitted to the Board in support of the application, the Board makes the following findings of fact:

- 1) Applicant is seeking a special use permit to operate an auto body repair shop upon the Property.

<sup>1</sup> The Restrictive Covenant, dated May 5, 2006 was in consideration of the Incorporated Village of Mineola Board of Trustees grant of a special use permit for the operation of an auto body repair and paint shop upon the property located at 381 Sagamore Avenue, Mineola, New York.

- 2) There currently exists a Restrictive Covenant which runs with the land that prohibits auto body repair shops/automotive industry use upon the Property;
- 3) The hours of operation would be 8:00 a.m. to 6:00 p.m. Monday-Friday and 8:00 a.m. to 2:00 p.m. Saturday and closed on Sunday;
- 4) Applicant currently operates an auto body repair shop at 100 Windsor Avenue, Mineola, New York;
- 5) Applicant proposes the installation of a spray booth;
- 6) The physical condition of the area has improved since the Restrictive Covenant was executed. Further, the economic conditions have deteriorated over this same period;
- 7) The proposed use, subject to the conditions imposed by this Board, will provide a desirable service and convenience to the Village with no substantial impact to the area.

Based upon the above findings, it is hereby determined that the proposed use, subject to the conditions stated below, is harmonious to the “B-1” District, will conform to the general character of the neighborhood and that the public health, morals, safety and general welfare of such neighborhood will be secured by the granting of the requested Special Use Permit. Based upon the original purpose of the restrictive covenant, to wit the prevention of an auto body repair shops/automotive industry use opening upon the property without review by the Board of Trustees and further based upon the improved area and the current economic climate, the Board finds that the Restrictive Covenant no longer serves the intended purpose and thus, has no substantial benefit to the Village. Further, it is hereby determined that the Special Use Permit will provide a desirable facility to the area and will not be incongruous to the neighborhood by reason of excessive traffic.

**IT IS THEREFORE RESOLVED**, that the Special Use Permit is **GRANTED** subject to the following conditions:

- 1) The operation of the facility shall be self-contained within the interior of the building and no work shall be performed on any vehicle outside of the building;
- 2) All customer vehicles shall be stored off-street;
- 3) Applicant shall obtain all necessary licenses, permits and approvals from all interested governmental agencies having jurisdiction prior to operation and shall remain in compliance at all times;
- 4) Vehicles shall not be permitted to idle upon the Property;
- 5) The property shall be maintained in a clean and broom-swept condition at all times;
- 6) Each of these conditions is material to the approval granted by the Board of Trustees. Violations of any of them shall subject the applicant or its successors to enforcement pursuant to the Village’s Municipal Code, including possible revocation of this special permit;
- 7) The representations made by Applicant on the record in this proceeding have been deemed material to this application and have been relied upon by the Board of Trustees in its deliberations and decisions. Said representations are deemed to be

part of the conditions of this special permit; and

- 8) Violation of a condition set forth in this decision shall be deemed a violation of the Village Zoning Law and shall subject the owner or occupant of the premises to all penalties set forth in the Zoning Law.

**IT IS THEREFORE FURTHER RESOLVED** that the Restrictive Covenant, dated May 5, 2006 is **EXTINGUISHED AND CANCELED**.
