Mayor Scott P. Strauss stated that he had completed another round of Community Forums and commented that he will continue to have these informal meetings throughout the year; reminded residents to subscribe to email notifications on the village’s website for the latest news and announcements; and announced that the Mineola Fire Department is starting “Operation Santa”. Mayor Strauss complimented Superintendent of Public Works Tom Rini and his staff for their continuing efforts in cleaning up from previous storms and in decorating the village for the holidays. Mayor Strauss congratulated Chris Gavin on becoming the next Boy Scouts Troop 45 Eagle Scout and thanked Steve Grosskoft for his leadership as Scout Master; and congratulated Chief Joseph Pratt and his wife Anne Marie on the birth of their first son.
