Mayor Scott P. Strauss announced that the Bruce Terrace Flood Mitigation project is progressing and reported that the Jericho Turnpike repaving project has encountered delays, but will be completed early next year. Mayor Strauss reported on the actions taken before, during, and after Hurricane Sandy commenting that the village has taken a very aggressive approach to debris removal and recovery operations and remarked that responses were well coordinated between the Department of Public Works, the Building Department, and Village Hall, the Mineola Fire Department, the Mineola Ambulance Corp and the Mineola Auxiliary Police. Mayor Strauss thanked the departments for the extraordinary efforts given by all involved.

Trustee Lawrence A. Werther complimented the various departments of the village on their performance during the hurricane.

Trustee Paul S. Cusato thanked Mayor Strauss for his leadership, village employees for their dedicated service, and the Mineola Fire Department, Mineola Volunteer Ambulance Corp (MVAC) and Mineola Auxiliary Police Department volunteers for their efforts during the storm to protect the lives and property of our residents.

Trustee Paul A. Pereira complimented our village employees and volunteers for their efforts to ensure the safety of the residents and thanked Mayor Strauss for his leadership.

Trustee George R. Durham thanked the employees, volunteers, and residents who all came together to help those in need during Hurricane Sandy.
