Mayor Scott P. Strauss provided an update of the status of the Bruce Terrace Flood Mitigation Project, announcing that the bids have been opened and Superintendent of Public Works Thomas J. Rini is evaluating the qualifications of the bidders. Mayor Strauss stated that the village has won the lawsuit regarding the proposed 7-Eleven decision, noting that the developer has the right to appeal within 30 days; provided a update on the status of the New York State Jericho Turnpike repaving project delay; and congratulated Sam and Delores Donato on being selected the “Italian Couple of the Year” by the Corpus Christi Council of the Knights of Columbus. Mayor Strauss congratulated Mineola Fire Department Ex-Captain Joseph Tartaglia, Jr. on being honored by the Town of Hempstead as Firefighter of the Year. Mayor Strauss reminded residents to see the Golden Age Club Art Show at Mineola Memorial Library and encouraged residents to attend the children’s Halloween Party at Village Hall October 26th at 7:00 pm.

Trustee Lawrence A. Werther announced that the Nassau Pops is scheduled to have a fundraiser for Cerebral Palsy at the Tilles Center at C.W. Post on Sunday October 21, 2012. Trustee Werther encouraged everyone to come to the Halloween Party on Friday October 26 and reminded residents to vote on Election Day November 6, 2012.

Cusato congratulated Sam and Delores Donato for being honored as the Knights of Columbus “Italian Couple of the Year”; announced that he attended the Mineola High School alumni reunion commenting how nice it was to see so many alumni attending these events; and congratulated Mineola Fire Department Ex-Captain Joseph Tartaglia on being honored “Firefighter of the Year” by the Town of Hempstead.
