Mayor Scott P. Strauss congratulated Mineola Little League players who won the National Junior Baseball League Championship, presented them with certificates, and congratulated them on their achievement. Mayor Strauss also presented a proclamation celebrating the 75th Anniversary of the founding of the Mineola Fire Department Ladies Auxiliary and thanked them for their selfless contribution to the community and to the Mineola Fire Department.
