Mayor Scott P. Strauss commented that Trustees' Cusato, Werther, Durham and he attended the New York Conference of Mayors annual meeting, stated that he attended a meeting with Senator Jack Martins and representatives of the Long Island Rail Road regarding the uncovered freight car issue and stated that they are working to rectify this situation. Mayor Strauss noted that he administered the oath of office to the new officers of the Mineola Chamber of Commerce wished incoming President Bill Green good luck and thanked outgoing President Ray Sikorski for his work for the Chamber and the Village of Mineola. Mayor Strauss reminded residents of the Mineola Kiwanis' and Mineola High School Bicycle Safety Day on Sunday May 20 from 12:00 PM – 3:00 PM, a Public Hearing on Wednesday May 23 at 6:30 PM on the 250 Old Country Road project, and the Annual Mineola Memorial Day Parade on May 28 at 11:00 AM starting at Wilson Field. Mayor Strauss stated that Moody's has reaffirmed the AA3 bond rating for the Village of Mineola. This will assist us in getting a better interest rate on the redemption and refunding of the 2003 Serial Bonds saving the Village of Mineola \$1.4M over 12 fiscal years.

Trustee Lawrence A. Werther commented on the good that comes out of attending the New York Conference of Mayors meetings, especially the ability to learn what is going on in the State Legislature and encouraged residents to continue to write their State representatives to oppose New York State's overseeing SEQRA process for village applications allowing municipalities control over projects being built within the villages. Trustee Werther commented on a "Night on the Town" event and how successful it was raising over \$73,000, and congratulated incoming Mineola Chamber of Commerce President Bill Green.

Trustee Paul S. Cusato commented on how worthwhile and interesting it is to attend the New York Conference of Mayors; stated that he attended the Town of North Hempstead Downtown Revitalization Seminar, and noted that many of the ideas presented are already being utilized in the Village of Mineola. Trustee Cusato congratulated incoming President of the Mineola Chamber of Commerce, Bill Green, and thanked outgoing President Ray Sikorski; congratulated Christine Napolitano and Artie Barnett on their recent election on the Mineola School Board and thanked John McGrath for all his effort in prior years. Trustee Cusato announced that Dominick's Deli's application was approved by the Town of North Hempstead Board of Zoning and Appeals and stated that on Sunday May 20 Company 1 of the Mineola Fire Department will hold an awards ceremony recognizing those with many years of service.

Trustee Paul A. Pereira commented that the "Night on the Town" was a great success and thanked all those that made it happen; thanked outgoing President Ray Sikorski of the Mineola Chamber of Commerce and welcomed incoming President Bill Green. Trustee Pereira congratulated the two board members that were elected to the Mineola School Board and thanked John McGrath for his service

Trustee George R. Durham commented on how successful the "Night on the Town" fundraiser was raising over \$70,000; stated that the New York Conference of Mayors annual meeting was very informative noting that it was interesting hearing what other municipalities are doing; and reminded residents of the May 23 Public Hearing on the 250 Old Country Road project and encouraged all to attend. Trustee Durham commented on the Memorial Day Parade and requested residents come and support our troops; Trustee Durham noted that June 2 is Mineola Athletic Association's Family Fun Day at the little league field off Willis Ave, and June 17 is Boy Scout Troop 45 Annual Father's Day Pancake Breakfast.
