RELIEF REQUESTED: Application For a Special Permit pursuant to Chapter 30, Section 30.5

This Board has received a joint written application from Polimeni International, LLC ("Polimeni") and Mill Creek Residential Trust, LLC ("Mill Creek") seeking to amend a special permit issued by the Incorporated Village of Mineola pursuant to its Development Incentive Bonus Law for the construction of a rental apartment building of 275 units and a 36 unit senior affordable rental apartment building. The main rental apartment building, known as The Winston, is located at the northwest corner of the intersection of Old Country Road and Willis Avenue. The senior affordable rental apartment building, known as The Churchill, is located on Front Street just west of Roslyn Road.

A special permit was originally issued to Polimeni relative to The Winston on July 2, 2008 for a residential condominium building and an affordable senior housing condominium. That decision was modified by means of an Amended and Superseding Decision dated December 12, 2010. According to the Amended and Superseding Decision, Polimeni was permitted to construct a 275 unit rental building in lieu of the condominium. By a Second Amended Decision, dated October 12, 2011, Polimeni was granted permission to construct a 36 unit affordable senior rental building in lieu of a condominium.

Polimeni has entered into an agreement with Mill Creek according to which Mill Creek, through a subsidiary known as Mineola 150 LLC, will take an assignment of Polimeni's development rights concerning the overall project. Both enterprises now seek further modifications of the special permit.

By letter dated April 19, 2012, the following modifications are requested:

- 1. Eliminate the requirement that a parking garage be built on the north side of Third Street;
- 2. Approve the relocation of 40 parking spaces which were to be provided in the parking garage on Third Street to be constructed by Polimeni at the site of a former restaurant at the northeast corner of Third Street and Willis Avenue, which will be constructed upon issuance of the building permit for The Winston to Village specifications and ownership to be conveyed by deed to the Village;
- 3. Approve a 2-year lease of the parking lot with developer's designee from commencement of construction at a monthly rental of \$5,000.00, for the placement of an office trailer and the use of the remainder of the parking lot for developer's designee's contractors and employees. At the option of the developer's designee, the lease may continue on a month-to-month basis at the same monthly rental until the issuance of the final certificates of occupancy for The Winston and The Churchill. The parking lot will be returned to the Village at the end of the lease and restored to original condition;
- 4. Approve a declaration of restrictive covenants running to the benefit of Nassau County whereby the Village agrees in perpetuity to eliminate on-street parking on the north side of Old Country Road in front of The Winston; and
- 5. Approve a PILOT agreement with the Nassau County Industrial Development Agency with respect to The Winston and The Churchill.

By that same letter, the following offers are made to the Village:

- 1. Enter into a Host Community Benefits Agreement with respect to The Winston.
- 2. Accelerate the Development Incentive payments as follows:
 - a. One Million (\$1,000,000.00) Dollars upon the issuance of a building permit for The Winston;
 - b. One Million (\$1,000,000.00) Dollars six months after the issuance of building permit for The Winston; and
 - c. One Million (\$1,000,000.00) Dollars upon issuance of the certificate of occupancy for The Winston.
- 3. Construct The Winston and The Churchill concurrently.

This Board has reviewed the request and makes the following determinations based upon the best interests of the Village and in order to promote the health, safety and welfare of the community:

- 1. The request to eliminate the requirement that a parking garage be built on the north side of Third Street is GRANTED;
- 2. The request to relocate 40 parking spaces designated for Village use to a fullyconstructed parking lot (in accordance with Village specifications) at the site of a former restaurant at the northeast corner of Third Street and Willis Avenue is GRANTED and the offer to deliver a deed upon issuance of the building permit for The Winston to the parking lot property to the Village is ACCEPTED;

- 3. The application to enter into a two-year lease with the Village for the said parking lot according to which the developer will pay to the Village a monthly rental of \$5,000.00 is GRANTED. The developer's request to receive an option to continue in possession of the parking lot after the expiration of the lease and until the issuance of final certificates of occupancy for The Winston and The Churchill is GRANTED. The parking lot will be returned to the Village restored to original condition;
- 4. The application that the Village approve a declaration of restrictive covenants running to the benefit of Nassau County whereby the Village agrees in perpetuity to eliminate on-street parking on the north side of Old Country Road in front of The Winston is GRANTED; and
- 5. The request that the Village approve a PILOT agreement with the Nassau County Industrial Development Agency with respect to The Winston and The Churchill in accordance with the following schedule is GRANTED:
