Deputy Mayor Werther reported that he attended the Mineola Chamber of Commerce meeting on October 20, 2010 when speaker Mr. William Schoolman spoke about the MTA Payroll Tax and efforts to have it repealed. Deputy Mayor Werther reminded everyone that on October 29, 2010 from 7:00 PM – 9:30 PM the Village of Mineola will host its annual Halloween Party for Mineola residents.
