Refining Yorktown, Inc. f/k/a Giant Yorktown, Inc., Flint Hills Resources, LP, Koch Industries, Inc. and Crown Central, LLC in the amount of \$16,493.49 net of legal fees (\$5,497.83) and a current installment of costs associated with litigation (\$25,000.00).
