Mayor Scott P. Strauss stated that October is National Breast Cancer Awareness Month and encouraged residents to get screened; reported that he attended the Mineola High School Homecoming Parade and congratulated the football team on their win; reported that the Chamber of Commerce Mineola Street Fair went well and thanked dunk tank volunteers; reminded residents that holidays are coming and encouraged them to shop locally; reported that the President of Ireland visited the Irish American Society in Mineola; announced that the Mineola Fire Department will have their Open House October 6; congratulated Linda Guggino on her retirement after 47 years at the library; congratulated Village Clerk Joe Scalero on being elected as President of NYS Association of City and Village Clerks; thanked the Mineola Auxiliary Police Department

for all they do at community events, from planning in advance, rerouting traffic, and patrolling, under the leadership of Chief Spae; reported that Mineola Junior Fire Department member Robbie Wilgosz recently saved a victim from choking, and announced that there will not be a Board of Trustees meeting next week in observance of Yom Kippur.

Trustee Paul A.
