Mayor Martins reported on his participation in the Auxiliary Police Department's "National Night Out" program, the successful conclusion of the Summer Recreation program, an update on the Town of North Hempstead's abandoned efforts to reinstate Flow Control, a meeting between the NYS Department of Transportation and the Village of Mineola, and Long Island Railroad freight issues.

Trustee Lawrence Werther reported on summer activity opportunities in Mineola, a recent *Newsday* article that highlighted Chaminade High School, and certain reported incidents of crimes in Mineola.

Trustee Paul Cusato commended the Nassau Pops on their July 25 performance and reported on his attendance at the "National Night Out" event.

Trustee Kennedy discussed recent bank robberies in Mineola as being part of countywide serial bank robberies and reported on the success of the Summer Recreation program.

Trustee Paul Pereira noted the wide range of Village resources that are available to residents throughout the summer months such as the pool, summer concerts, and parks. Trustee Pereira also spoke about the recent NYS Assembly's Long Island Railroad Third Track hearing and thanked those residents who addressed the committee.

Mayor Martins reminded residents that the Board of Trustees would be addressing the proposed fence law, and the pending application by Winthrop University Hospital to construct a parking facility at its regular August 13, 2008 hearing date. Mayor Martins also noted that those hearings will start at 7:30 pm instead of the customary 6:30 pm start.
