DECISION:

Jason Jin (hereinafter, "Applicant") is before this Board, pursuant to Chapter 550, Section 550-12 of the Municipal Code of the Incorporated Village of Mineola, for a special use permit to establish a restaurant serving sushi and noodles upon the property known as 90-18 Jericho Turnpike, Mineola, New York (known and designated on the Nassau County Land and Tax Map as Section 9, Block 336, Lot 418) (hereinafter, the "Property").

By Notice of Disapproval, Applicant's building permit was denied. The Building Inspector determined that the proposed application is contrary to the Village's zoning regulations. Applicant was thus required to seek relief before the Board of Trustees for a special use permit for the establishment of a restaurant upon the Property.

A referral of the application was made to the Nassau County Planning Commission. The Nassau County Planning Commission recommended that this Board take whatever action it deems appropriate. Based upon the evidence adduced at the public hearing, and the documentation submitted to the Board in support of the application, the Board makes the following findings of fact:

- 1) Applicant is seeking a special use permit for the establishment of a restaurant serving sushi and noodles upon the Property;
- 2) Applicant is proposing a thirty-seven (37) seat restaurant;
- 3) Applicant's hours of operation are 11:30 am to 10:30 pm, Sunday to Thursday and 11:30 am to 11:00 pm Friday and Saturday;
- 4) Applicant will utilize a private carter and store all putrescible waste refuse indoors until pick-up; and
- 5) The proposed use, subject to the conditions imposed by this Board, will provide a desirable service and convenience to the Village.

Based upon the above findings, it is hereby determined that the proposed use, subject to the conditions stated below, is harmonious to the "B-1" District, will conform to the general character of the neighborhood, and that the public health, morals, safety and general welfare of such neighborhood will be secured by the granting of the requested Special Use Permit. Further, it is hereby determined that the Special Use Permit will provide a desirable facility to the area and will not be incongruous to the neighborhood by reason of excessive traffic.

IT IS THEREFORE RESOLVED, that the Special Use Permit is **GRANTED** subject to the following conditions:

- Applicant shall cause all refuse to be removed from the premises by a private carter at Applicant's expense. All refuse shall be stored indoors until pick-up and all putrescible waste shall be refrigerated until pick-up. All waste pick-ups shall take place between the hours of 7:00 a.m. and 9:00 p.m. only;
- 2) All deliveries to the Property shall be by box-truck or delivery van during non-peak traffic hours. The Property shall not be serviced by any tractor trailers;
- 3) The premises shall be maintained in a clean condition at all times;
- Each of these conditions is material to the approval granted by the Board of Trustees. Violations of any of the conditions of this Special Use Permit shall subject the applicant or its successors to enforcement pursuant to the Village's Municipal Code, including possible revocation of this Special Use Permit;
- The representations made by Applicant on the record in this proceeding have been deemed material to this application and have been relied upon by the Board of Trustees in its deliberations and decision. Applicant's representations are deemed to be part of the conditions of this Special Use Permit; and

6) Violation of a condition set forth in this Special Use Permit shall be deemed a violation of the Village Zoning Law and shall subject the owner or occupant of the premises to all penalties set forth in the Zoning Law.

By Notice of Disapproval, Applicant's building permit was denied. The Building Inspector determined that the proposed application is contrary to the Village's zoning regulations. Applicant was required to seek relief before the Board of Trustees for a special use permit to establish tutoring and learning center facility upon the Property.

Based upon the evidence adduced at the public hearing, and the documentation submitted to the Board in support of the application, the Board makes the following findings of fact:

- 1) Applicant is seeking a special use permit to establish a tutoring and learning center upon the property known as 80 East Old Country Road, Mineola, New York;
- 2) Applicant has removed the previously proposed outdoor play area located in the parking lot;
- 3) Applicant has reduced the scale of the proposed tutoring and learning center. The center will only utilize the first floor and parts of the lower level. No use shall be located on the second floor;
- 4) Applicant operates learning centers in Deer Park, Hicksville and Riverheard;
- 5) The Property is serviced by a twenty (20) space parking lot;
- 6) Applicant anticipates approximately 25 students maximum at any one time at the Property; and
- 7) Applicant anticipates the hours of operation to be 10:30 am to 7:00 pm, Monday-Friday and Saturday 10:00 am to 1:00 pm. Closed on Sundays.

Based upon the above findings, it is hereby determined that the proposed use, subject to the conditions stated below, is harmonious to the "B-2" District, will conform to the general character of the neighborhood, and that the public health, morals, safety and general welfare of such neighborhood will be secured by the granting of the requested Special Use Permit. Further, it is hereby determined that the Special Use Permit, subject to the conditions below, will provide a desirable facility to the area and will not be incongruous to the neighborhood by reason of excessive traffic.

IT IS THEREFORE RESOLVED, that the Special Use Permit is **GRANTED** subject to the following conditions:

- 1) The operation of the facility shall be self-contained within the interior of the building;
- 2) There shall be no outdoor use associated with the Applicant's tutoring and learning center including, but not limited to, any outdoor playground/recreation space;
- 3) Applicant shall not conduct any summer camps at the Property;

- 4) There shall be no day-care and/or early education pre-k classes at the Property;
- 5) Applicant shall only utilize the first floor and parts of the lower level. No use shall be located on the second floor;
- 6) The Property shall not be serviced by any buses, vans or any other group pickup vehicles:
- 7) Applicant shall provide for at least 12 on-site parking spaces;
- 8) Applicant shall provide instructions to all clients to only utilize Old Country Road to Jupiter Avenue as the entrances/exit path to the Property;
- 9) No food shall be sold on the premises;
- 10) The Property shall be properly maintained at all time;
- Each of these conditions is material to the approval granted by the Board of Trustees. Violations of any of the conditions of this Special Use Permit shall subject the applicant or its successors to enforcement pursuant to the Village's Municipal Code, including possible revocation of this Special Use Permit;
- The representations made by Applicant on the record in this proceeding have been deemed material to this application and have been relied upon by the Board of Trustees in its deliberations and decision.
