Mayor Paul A. Pereira announced that the John S. DaVanzo Community Pool will open Saturday, June 18; discussed the construction at Wilson Park; reminded residents that the first Summer Concert in the Park will be Saturday, June 18 with a performance by Swingtime Big Band; stated that the summer recreation program is back; stated that he attended Boy Scout Troop 200's Eagle Scout ceremony and the Mineola Junior Fire Department Installation Dinner; reported that the Board of Trustees presented a \$2,500 check to the Golden Age Club; thanked firefighter Ken Cotroneo, firefighter Chris Franz and scoutmaster Steve Grosskopf for organizing the Memorial Day Parade and Ceremony, adding that there was a great turnout along the parade route and at Memorial Park; announced that the Portuguese Carnival will be held June 10-12 at Wilson Park, and the Portugal Day Parade will be on Sunday, June 12.
