Mayor Scott P. Strauss announced that the FY 2016/17 village budget anticipates a 0% tax increase and thanked board members and employees who helped make this possible through fiscal restraint, good management, and efforts throughout the year in being responsible to village taxpayers; announced new business openings in Mineola; noted that the recently approved commercial façade improvements and rehabilitation program was already underway; reminded residents of the upcoming *Nite on the Town* fundraiser, and the Little League Opening Day parade April 9. Mayor Strauss also reported on his attendance at the annual Irish Independence ceremony held at the Nassau County Courts.

Trustee Paul A. Pereira thanked residents for their support in his recent reelection and congratulated Trustee Paul Cusato on his reelection; announced there will be a health fair and blood drive April 10 at the Mineola Portuguese Center; reported on his participation at a meeting with the NYS Governor regarding the LIRR Third Track proposal and a meeting with the NYS Department of Conservation regarding Flow Control (solid waste management) organized by NYS Senator Jack M. Martins. Trustee Pereira also spoke about the *Nite on the Town* event, reminded residents that there is a village budget hearing scheduled for April 13, and offered his condolences on the passing of Nick Liakonis.

Trustee Paul S. Cusato congratulated Trustee Pereira on his reelection, thanked the Portuguese Lions Club for its successful annual breakfast and the Mineola Fire Department volunteers for their response to several recent incidents, including two house fires. Trustee Cusato also commented on a meeting of the Mineola Historical Society, the upcoming MAA Little League Opening Day Parade, and announced that a MAA reunion is currently being planned for October 15, 2016.

Trustee George Durham congratulated Trustees Pereira and Cusato on their reelection, commented on the strength of the proposed FY 2016/17 budget, noting in particular that there will be significant savings next year by not having an election, and reminded residents of the upcoming little League Opening Day Parade. Trustee Durham also reminded residents that the fist 2016 Town of North Hempstead S.T.O.P. date is scheduled for April 9, 2016.
