Resolution No. 067-23

Resolution to declare an emergency situation and dispense with bidding requirements for the repair/installation of a microprocessor based HydroAccel control system at the Mineola Library all in accordance with General Municipal Law §103(4) and the Village Procurement Policy.

Background:

The Village has been advised by Charles Sleefe, Library Director, and the numerous elevator repair/maintenance companies, that the current system at the Library is damaged, and inoperable arising from a power surge; and

The operation of the Village Library without an operable elevator system creates an emergency situation that could result in a threat to the health, safety and welfare of its patrons and employees; and

General Municipal Law, §103 entitled "Advertising for Bids and Offers; Letting of Contracts; Criminal Conspiracies", Subsection (4) provides that:

"Notwithstanding the provisions of subdivision one of this section, in the case of a public emergency arising out of an accident or other unforeseen occurrence or condition whereby circumstances affecting public buildings, public property or the life, health, safety or property of the inhabitants of a political subdivision or district therein, require immediate action which cannot await competitive bidding or competitive offering, contracts for public work or the purchase of supplies, material or equipment may be let by the appropriate officer, board or agency of a political subdivision or district therein."

The Village's Procurement Policy provides that the necessity of competitive bidding can be dispensed with in emergency situations.

NOW, THEREFORE, BE IT RESOLVED, that the Village of Mineola Board of Trustees hereby declares an emergency situation and dispenses with bidding requirements for the repair/installation of a microprocessor based HydroAccel control system at the Mineola Library all in accordance with General Municipal Law §103(4) with General Municipal Law §103(4) and the Village Procurement Policy; and

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the Village of Mineola Board of Trustees hereby awards the emergency repair/installation of a microprocessor based HydroAccel control system at the Mineola Library to Otis Elevator Company in the amount of \$95,500.00 (to be reduced by 3% with a 90% up front payment) as having presented the most responsible proposal; and

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the emergency repair shall be funded from insurance claim proceeds in the amount of \$57,850.00 with the remaining balance to be paid from the Library Fund and/or Unreserved Fund Balance of the Library Fund.
