DECISION:

Benjamin Musheyev (hereinafter, "Applicant") is before this Board pursuant to Chapter

550, Section 550.12.B of the Municipal Code of the Incorporated Village of Mineola for a special

use permit to establish a dry steam car wash/detailing use with the sale of pre-packaged food and

beverages upon property known as 99 Jericho Turnpike, Mineola, New York (known and

designated on the Nassau County Land and Tax Map as Section 9, Block 450, Lots 242-243)

(hereinafter, the "Property").

By Notice of Disapproval, dated May 20, 2016, Applicant's building permit was denied.

The Building Inspector determined that the proposed application is contrary to the Village's zoning

regulations in that the establishment of a dry steam car wash/detailing use with the sale of pre-

packaged food and beverages upon the Property requires a special use permit. Therefore, Applicant

was required to seek relief before the Board of Trustees for a special use permit.

On August 10, 2016, a referral of the application was made to the Nassau County Planning

Commission. By letter, dated August 17, 2016, the Nassau County Planning Commission

recommended that this Board take whatever action it deems appropriate. Based upon the evidence

adduced at the public hearing, and the documentation submitted to the Board in support of the

application, the Board makes the following findings of fact:

1) Applicant is seeking a special use permit to establish a dry steam car wash/detailing with the sale of pre-packaged food and beverages upon the property known as 99

Jericho Turnpike, Mineola, New York;

2) The hours of operation will be 6:00 am to 10:00 pm;

3) Applicant anticipates having twenty (20) employees at the Property;

4) The estimated time for a car wash is ten (10) to (20) minutes;

5) The business will not be a self-service car wash;

6) Applicant will valet vehicles waiting for service upon the Property (maximum of six

vehicles at a time); and

7) Applicant shall utilize disposable wipes that will be recycled.

Based upon the above findings, it is hereby determined that the proposed use, subject to the conditions stated below, is harmonious to the "B-1" District, will conform to the general character of the neighborhood and that the public health, morals, safety and general welfare of such neighborhood will be secured by the granting of the requested Special Use Permit. Further, it is hereby determined that the Special Use Permit will provide a desirable facility to the area and will not be incongruous to the neighborhood by reason of excessive traffic.

IT IS THEREFORE RESOLVED, that the Special Use Permit is **GRANTED** subject to the following conditions:

- 1) The Property shall be maintained in a clean and broom-swept condition at all times. Snow shall be removed promptly from all sidewalks surrounding the Property;
- 2) Applicant shall not prepare any food upon the Property;
- Applicant shall submit within fifteen (15) days of the date of this decision a traffic circulation plan for the entire Property. The plan shall indicate that the Maple Avenue curb cut is for the ingress of vehicles only and the Jericho Turnpike curb cut is for the egress of vehicles only. The plan shall also demonstrate the designated vehicle waiting area upon the Property;
- 4) Applicant shall install and maintain a "No-Left Turn" sign at the exit along Jericho Turnpike;
- 5) There shall be no auto body work or oil changes/inspections performed upon the Property;
- 6) Pursuant to Applicant's representation at the Public Hearing, any vehicle not waiting upon the Property for service shall be instructed by Applicant to return at another scheduled time;
- 7) Pursuant to Applicant's letter, dated September 16, 2016, the hours of operation will be 6:00 am to 10:00 pm;
- 8) Pursuant to Applicant's representation at the Public Hearing, there will be no food/beverages deliveries to the Property;
- Property. Applicant shall not service (i.e. clean, detail, dry, wax or vacuum) or store any vehicle upon any public roadway within the Incorporated Village of Mineola. Further, Applicant shall not permit any vehicle to stop, stand, wait, idle and/or queue for services at the Property upon any public roadway within the Incorporated Village of Mineola;
- 10) Applicant shall not utilize the municipal storm sewer system for any waste water run-off associated with the operation of the business at the Property;
- All lighting shall be designed such that it shall shine upon the Property only and shall not be directed towards any neighboring residences;
- The Village shall maintain jurisdiction over the site, particularly with respect to the safety and convenience of ingress into and egress from the Property. In the event that such entrance/exit shall require modification, the Applicant shall make further application before the Board of Trustees for an amendment of this approval or the Board of Trustees shall direct such modification;

- Each of these conditions is material to the approval granted by the Board of Trustees. Violations of any of them shall subject the Applicant or it successors to enforcement pursuant to the Village's Municipal Code, including possible revocation of this Special Use Permit;
- The representations made by Applicant on the record in this proceeding have been deemed material to this application and have been relied upon by the Board of Trustees in its deliberations and decisions. Said representations are deemed to be part of the conditions of this Special Use Permit; and
- Violation of a condition set forth in this decision shall be deemed a violation of the Village Zoning Law and shall subject the owner or occupant of the Property to all penalties set forth in the Zoning Law.

Mayor Scott P.
