Mayor Scott P. Strauss recognized Mineola High School senior Neal Ressa who is shadowing him for his senior project; congratulated Girl Scout Award recipients on their Bronze, Silver, and Gold awards; attended the Nassau County Police Department 3rd Precinct's community forum; reported that the annual halloween party was a success; announced the opening of the Music School of New York City on Jericho Turnpike; reminded residents that Village Hall is closed on November 8 for Election Day; reminded residents that winter is coming and to follow the snow code; stated that residents should sign up on the village website for notices; congratulated Giacomo Ciccone, Sr. on his retirement and thanked him for his many years of service; announced that the 75th anniversary of Pearl Harbor is December 7 and that veterans of World War II will be recognized at the Village Board meeting that night.
