# **DECISION:**

Taco Blvd (d/b/a Burrito Blvd) (hereinafter, "Applicant") is before this Board pursuant to Chapter 550, Section 550.13 of the Municipal Code of the Incorporated Village of Mineola for a special use permit for the establishment of a Mexican restaurant with the sale of food and beverages upon the property known as 98 Mineola Boulevard, Mineola, New York (known and designated on the Nassau County Land and Tax Map as Section 9, Blocks 419, Lot 140) (hereinafter, the "Property").

By Notice of Disapproval, dated July 21, 2015, Applicant's building permit was denied. The Building Inspector determined that the proposed application is contrary to the Village's zoning regulations in that the establishment of a Mexican restaurant with the sale of food and beverages upon the Property requires a special use permit. Applicant was thus required to seek relief before the Board of Trustees for a special use permit. Based upon the evidence adduced at the public hearing, and the documentation submitted to the Board in support of the application, the Board makes the following findings of fact:

- 1) Applicant is seeking a special use permit to establish a Mexican restaurant with the sale of food and beverages upon the property known as 98 Mineola Boulevard, Mineola, New York;
- 2) The proposed use, subject to the conditions imposed by this Board, will provide a desirable service and convenience to the Village;

Based upon the above findings, it is hereby determined that the proposed use, subject to the conditions stated below, is harmonious to the "B-2" District, will conform to the general character of the neighborhood and that the public health, morals, safety and general welfare of such neighborhood will be secured by the granting of the requested Special Use Permit. Further, it is hereby determined that the Special Use Permit will provide a desirable facility to the area and will not be incongruous to the neighborhood by reason of excessive traffic.

IT IS THEREFORE RESOLVED, that the Special Use Permit is GRANTED subject

to the following conditions:

- 1) All deliveries shall occur on-site during off-peak traffic hours and shall not occur before 6am;
- 2) All ventilation/exhaust shall be vented through the building up to the roof and shall be directed away from residential properties. The ventilation/exhaust shall be in compliance with the New York State Fire Prevention and Building Code, the Regulations of the Nassau County Fire Marshal and the Rules of all agencies having jurisdiction;
- 3) All putrescible waste shall be refrigerated indoors until pick-up;
- 4) Each of these conditions is material to the approval granted by the Board of Trustees. Violations of any of them shall subject the applicant or it successors to enforcement pursuant to the Village's Municipal Code, including possible revocation of this special permit;
- 5) The representations made by Applicant on the record in this proceeding have been deemed material to this application and have been relied upon by the Board of Trustees in its deliberations and decisions. Said representations are deemed to be part of the conditions of this special permit; and
- 6) Violation of a condition set forth in this decision shall be deemed a violation of the Village Zoning Law and shall subject the owner or occupant of the premises to all penalties set forth in the Zoning Law.

# **DECISION:**

Pursuant to the Decision and Order of the Appellate Division of the Supreme Court, Second Judicial District, dated April 29, 2015, the special use application is **GRANTED**, subject to the following conditions:

1. The premises shall be maintained in a clean condition at all times.

2. All deliveries shall occur on-site during off-peak traffic hours. No delivery shall occur between the hours of 9:00 p.m. and 7:00 a.m, except for up to three (3) daily newspaper deliveries and one (1) daily combined distribution center delivery. As offered by the Applicant at the Public Hearing held on October 12, 2011, Applicant shall utilize only box trucks for all deliveries and shall enforce such a restriction on all of its vendors. <u>See</u> Hearing Transcript, pgs. 64-65.

3. The site shall be served by a private sanitation carter at the expense of the Applicant. As offered by the Applicant at the Public Hearing held on October 12, 2011, all putrescible waste shall be refrigerated indoors until pick-up. <u>See</u> Hearing Transcript, pg. 61. All garbage pick-ups shall take place between the hours of 7:00 a.m. and 9:00 p.m. only.

4. As offered by the Applicant at the Public Hearing held on October 12, 2011, all lighting shall be designed such that it shall shine upon the premises only and shall not be directed towards any neighboring residences. <u>See</u> Hearing Transcript, pgs. 68-69.

5. The garbage dumpster shall be maintained in a fully enclosed area and the gates to the area shall be closed at all times except during loading and pick-up. The garbage dumpster and surrounding area shall remain free from debris, odors and/or litter at all times.

6. As offered by the Applicant at the Public Hearing held on October 12, 2011, Applicant shall eliminate the existing most westerly curb cut on Jericho Turnpike. The remaining most easterly curb cut on Jericho Turnpike shall be restricted to right turn in and right turn out movements. <u>See</u> Hearing Transcript, pg. 20. Applicant shall install and maintain the necessary signage designating the restrictions for the entrance and exit.

7. As offered by the Applicant at the Public Hearing held on October 12, 2011, Applicant shall apply to the New York State Department of Transportation for authorization to install and maintain a curb channel for the curb cut on Jericho Turnpike that would direct vehicular ingress and egress via a right turn movement. Applicant shall provide the Village with the New York State Department of Transportation's decision. <u>See</u> Hearing Transcript, pgs. 73-74.

8. As offered by the Applicant at the Public Hearing held on October 12, 2011, Applicant shall restrict the egress along Jay Court to be left turn only. Applicant shall install and maintain the necessary signage. Applicant shall install and maintain channelized curbs that will direct vehicles to only make left turns when exiting the Property. <u>See</u> Hearing Transcript, pgs. 52-53.

9. Applicant shall install new curbs and sidewalks at the Property in accordance with New York State Department of Transportation criteria.

10. In the event of any damage to Village roads during construction, Applicant shall correct the damage in accordance with all applicable code requirements.

As offered by the Applicant at the Public Hearing held on October 12, 2011,
Applicant shall not engage in cooking activities upon the Property. <u>See</u> Hearing Transcript, pg.
62.

12. Applicant shall install and maintain a 6 foot PVC fence along the rear property line. <u>See</u> Hearing Transcript, pgs. 70-71 and 93.

13. As offered by the Applicant at the Public Hearing held on October 12, 2011, Applicant shall plant and maintain ten and a half foot natural buffer of evergreen landscaping along the rear property line. Applicant shall maintain all landscaping at the Property. Applicant shall install and maintain an automatic irrigation system. <u>See</u> Hearing Transcript, pgs. 21 and 93.

14. As offered by the Applicant at the Public Hearing held on October 12, 2011,
Applicant shall install and maintain an exterior security camera system. <u>See</u> Hearing
Transcript, pgs. 74-76. The security tapes shall be preserved for one (1) month.
