Strauss stated that in an effort to help local businesses, meters will be free on Saturdays in certain areas during the holiday season; encouraged residents to shop locally; announced that the Village Tree Lighting is Friday, December 6 at 7:00 pm; commented that the first snowfall of the season was this week, and reviewed snow regulations, and encouraged residents sign up for E-Notices.

Trustee Paul A. Pereira discussed the Grand Opening of Metro Mineola; stated that Senior Appreciation Day was a success; encouraged residents to attend the Village Tree Lighting and to call for Operation Santa visit as time slots are filling quickly; stated that he attended the Nassau County Coaches Association dinner to present the first annual Christian Melendez scholarship to Mineola High School senior Juan Lopez, and announced that a memorial soccer game and fundraiser dinner to raise money for the Christian Melendez scholarship fund will be held on January 3 at Mineola High School.

Trustee Paul S.
