DECISION:

Heidi Cohen (hereinafter, "Applicant") is before this Board pursuant to Chapter 550, Section 550.12.B of the Municipal Code of the Incorporated Village of Mineola for a special use permit to establish a children's party place upon the property known as 464 Jericho Turnpike, Mineola, New York (known and designated on the Nassau County Land and Tax Map as Section 9, Block 5, Lots 30-32, 64-68, 130) (hereinafter, the "Property").

By Notice of Disapproval, dated July 1, 2014, Applicant's building permit was denied. The Building Inspector determined that the proposed application is contrary to the Village's zoning regulations. Applicant was thus required to seek relief before the Board of Trustees for a special use permit to establish a dance and fitness studio upon the Property.

A referral of the application was made to the Nassau County Planning Commission. The Nassau County Planning Commission has recommended that this Board take whatever action it deems appropriate. Based upon the evidence adduced at the public hearing, and the documentation submitted to the Board in support of the application, the Board makes the following findings of fact:

- 1) Applicant is seeking a special use permit to establish a children's party place upon the property known as 464 Jericho Turnpike, Mineola, New York;
- 2) Applicant serves pizza and cake that is brought in from an outside vendor. Applicant will not be preparing or cooking food upon the Property;
- 3) The building is serviced by a parking lot in the rear of the Property;
- 4) The rear entrance is utilized as the main entrance to the building;
- 5) Applicant will have seven (7) employees and only three (3) employees will be scheduled at one-time;

6) Applicant anticipates three (3) ninety (90) minute parties on both Saturday and Sunday each week for twelve (12) to fifteen (15) children. The hours of operation will be 11:00 A.M. to 7:30 P.M.; and

7) The proposed use, subject to the conditions imposed by this Board, will provide a desirable service and convenience to the Village.

Based upon the above findings, it is hereby determined that the proposed use, subject to the conditions stated below, is harmonious to the "B-1" District, will conform to the general character of the neighborhood and that the public health, morals, safety and general welfare of such neighborhood will be secured by the granting of the requested Special Use Permit. Further, it is hereby determined that the Special Use Permit will provide a desirable facility to the area and will not be incongruous to the neighborhood by reason of excessive

IT IS THEREFORE RESOLVED, that the Special Use Permit is GRANTED subject to the following conditions:

1) The applicant will not prepare or cook food upon the Property;

2) Applicant shall encourage its customers to utilize the rear parking lot;

3) Each of these conditions is material to the approval granted by the Board of Trustees. Violations of any of them shall subject the applicant or it successors to enforcement pursuant to the Village's Municipal Code, including possible revocation of this special permit;

4) The representations made by Applicant on the record in this proceeding have been deemed material to this application and have been relied upon by the Board of Trustees in its deliberations and decisions. Said representations are deemed to be part of the conditions of this special permit; and

5) Violation of a condition set forth in this decision shall be deemed a violation of the Village Zoning Law and shall subject the owner or occupant of the premises to all penalties set forth in the Zoning Law.
