Mayor Scott P. Strauss reported on the recent snow storms and snow removal efforts; thanked the Department of Public Works, and reminded residents of their obligation regarding parking restrictions and snow clean-up. Mayor Strauss also reminded residents of the continuation of the Public Hearing on the proposed Village Green apartment complex at 199 Second Street Wednesday February 11 at 6:30 PM and encouraged their participation.

Trustee Paul A. Pereira complimented Mayor Strauss and department heads on the storm preparation efforts and the clean-up afterwards; commented on the differences between the clean-up efforts on Village roads vs. County roads; reported on his attendance at the Portuguese Heritage Society event welcoming the new Consul General from Portugal; noted that the Kiwanis Pancake Breakfast was held on Sunday and thanked all those who supported the efforts of the Kiwanis, commending those who volunteered making the event a great success.

Trustee Paul S. Cusato commended the Department of Public Works' employees for their efforts

during the recent snow storms; thanked the Mineola Fire Department first responders for their efforts maintaining “stand-by” status during the storms to insure the safety of residents. Trustee Cusato reported on the Portuguese Heritage Society event welcoming the new Consul General; congratulated the Irish American Society on the installation of their new officers; and thanked residents that helped clear fire hydrants near their homes during these past snow storms

Trustee George R. Durham reported on the Klondike Derby, congratulating the Boy Scouts of America Troop 45 for its victories; noted that he attended the welcoming of the new Consul General at the Portuguese Heritage Society, the installation of new officers at the Irish American Society, and the Kiwanis Pancake Breakfast. Trustee Durham announced that Cub Scouts Pack 246 will be holding its Blue & Gold Dinner on Saturday February 7.
