DECISION:

Hector Fonseca (hereinafter, “Applicant”) is before this Board pursuant to Chapter 550, Section 550.12.B of the Municipal Code of the Incorporated Village of Mineola for a special use permit to establish an ice cream parlor upon the property known as 156 Jericho Turnpike, Mineola, New York (known and designated on the Nassau County Land and Tax Map as Section 9, Block 322, Lots 16-18) (hereinafter, the “Property”).

By Notice of Disapproval, dated October 2, 2014, Applicant’s building permit was denied. The Building Inspector determined that the proposed application is contrary to the Village’s zoning regulations. Applicant was thus required to seek relief before the Board of Trustees for a special use permit to establish a dance and fitness studio upon the Property.

A referral of the application was made to the Nassau County Planning Commission. The Nassau County Planning Commission has recommended that this Board take whatever action it deems appropriate. Based upon the evidence adduced at the public hearing, and the documentation submitted to the Board in support of the application, the Board makes the following findings of fact:

- 1) Applicant is seeking a special use permit to establish an ice cream parlor upon the property known as 156 Jericho Turnpike, Mineola, New York;
- 2) The hours of operation will be 10:30 A.M. to 10:30 P.M. seven (7) days a week;
- 3) The main entrance will be on Jericho Turnpike with no rear entrance;
- 4) Applicant anticipates having two (2) employees; and

- 5) The proposed use, subject to the conditions imposed by this Board, will provide a desirable service and convenience to the Village.

Based upon the above findings, it is hereby determined that the proposed use, subject to the conditions stated below, is harmonious to the “B-1” District, will conform to the general character of the neighborhood and that the public health, morals, safety and general welfare of such neighborhood will be secured by the granting of the requested Special Use Permit. Further, it is hereby determined that the Special Use Permit will provide a desirable facility to the area and will not be incongruous to the neighborhood by reason of excessive traffic.

IT IS THEREFORE RESOLVED, that the Special Use Permit is **GRANTED** subject to the following conditions:

- 1) The site shall be served by a private sanitation carter at the expense of the Applicant;
- 2) Applicant shall maintain a maximum of eight (8) indoor seats at the Property;
- 3) The applicant will not prepare or cook food upon the Property;
- 4) All deliveries shall be made in the rear of the Property;
- 5) Each of these conditions is material to the approval granted by the Board of Trustees. Violations of any of them shall subject the applicant or its successors to enforcement pursuant to the Village’s Municipal Code, including possible revocation of this special permit;
- 6) The representations made by Applicant on the record in this proceeding have been deemed material to this application and have been relied upon by the Board of Trustees in its deliberations and decisions. Said representations are deemed to be part of the conditions of this special permit; and
- 7) Violation of a condition set forth in this decision shall be deemed a violation of the Village Zoning Law and shall subject the owner or occupant of the premises to all penalties set forth in the Zoning Law.

DECISION:

Yildiz Hidir (hereinafter, “Applicant”) is before this Board pursuant to Chapter 550, Sections 550.12 and 550.23 of the Municipal Code of the Incorporated Village of Mineola for a special permit to establish a gasoline dispensing station with a convenience store at the property located at 70 East Jericho Turnpike, Mineola, New York (known and designated on the Nassau County Land and Tax Map as Section 9, Block 366, Lot 93) (hereinafter, the “Property”).

By Notice of Disapproval, dated May October 29, 2014, Applicant's building permit was denied. The Building Inspector determined that the proposed application is contrary to the Village’s zoning regulations in that the establishment of a gasoline dispensing station with a convenience store on the Property requires a special use permit. Applicant was thus required to seek relief before the Board of Trustees for a special use permit.

Applicant made an application to the Board of Trustees for the required special use permit. The overall application was previously referred to the Nassau County Planning Commission. The Nassau County Planning Commission has recommended that this Board take whatever action it deems appropriate. At the public hearings on this matter, Applicant, apparently intending to induce this Board to grant the special permit, amended his original application to operate the business twenty-four (24) hours a day and seven (7) days per week, although not legally required to do so, to limit the hours of operation and to close both the gasoline station and the convenience store between the hours of 11 p.m. and 6 a.m. seven (7) days per week.

Based upon the evidence adduced at the public hearing and the documentation submitted to the Board in support of the application, the Board makes the following findings of fact:

- 1) Applicant intends to establish a gasoline dispensing station with a convenience store and four (4) pumps cable to service eight (8) cars at one time;
- 2) Applicant will keep all existing curb cuts (two [2] on Jericho Turnpike and two [2] on Columbus Parkway);
- 3) Applicant will not increase the footprint of the existing building upon the Property;
- 4) Applicant will be installing new underground fuel storage tanks;
- 5) The Applicant will own and operate the business on the Property; and
- 6) The proposed use, subject to full compliance with the below-listed conditions imposed by this Board, will provide a desirable service and convenience to the Village.

Based upon the above findings, it is hereby determined that the granting of the Application, requesting a special permit pursuant to Sections 550.12 and 550.23 of the Village Code for a gasoline dispensing station with a convenience store with limited hours of operation as stated below, will conform to the general character of the neighborhood and that the public health, morals, safety and general welfare of such neighborhood will be secured by the granting of the requested Special Use Permit. Further, it is hereby determined that the Special Use Permit will provide a desirable facility to the area and will not be incongruous to the neighborhood by reason of excessive traffic.

IT IS THEREFORE RESOLVED, that the Special Permit is **GRANTED** subject to the following conditions:

- 1) Pursuant to its offer on the record, Applicant's hours of operation shall be 6 a.m. to 11 p.m. for both the gasoline service station and the convenience store;
- 2) Applicant shall install and maintain landscaping along the perimeter of the Property;
- 3) No automotive/autobody work shall be conducted upon the Property;
- 4) The Applicant will not prepare or cook food upon the Property;
- 5) The site shall be served by a private sanitation carter at the expense of the Applicant and all pick-ups shall take place between the hours of 7:00 a.m. and 9:00 p.m. only;
- 6) Fuel deliveries will not be conducted during the peak hours of traffic activity;
- 7) All equipment/fire suppression systems shall be in compliance with the New York State Fire Prevention and Building Code, Nassau County Fire Marshal and the Rules of all agencies having jurisdiction;
- 8) Applicant shall install a No Left Turn sign at each exit along Columbus Parkway;
- 9) Deliveries will not be conducted during the peak hours of traffic activity and will not take place when the business is closed;
- 10) All lighting shall be designed such that it shall shine upon the premises only and shall not be directed towards any neighboring residences;
- 11) All roof mechanicals will be properly screened;
- 12) No audio messages, signals or announcements emanating from a gasoline pump shall be audible from a point beyond ten (10') foot radius from the pump;
- 13) Each of these conditions is material to the approval granted by the Board of Trustees. Violations of any of them shall subject the applicant or its successors to enforcement pursuant to the Village's Municipal Code, including possible revocation of this special permit;

- 14) The representations made by Applicant on the record in this proceeding and correspondence thereafter have been deemed material to this application and have been relied upon by the Board of Trustees in its deliberations and decisions. Said representations are deemed to be part of the conditions of this special permit; and
- 15) Violation of a condition set forth in this decision shall be deemed a violation of the Village Zoning Law and shall subject the owner or occupant of the premises to all penalties set forth in the Zoning Law.

This constitutes the Decision of the Board of Trustees. Applicant shall, within ten (10) days of the date of filing of this Decision, consent in writing to the conditions contained herein.

Failure to so consent shall render this Decision null and void.

Mayor Scott P.
