Mayor Scott P. Strauss stated that Lili's Boutique and JB Vintage had ribbon cutting ceremonies, and he encouraged residents to shop locally for the holidays; thanked staff for organizing the Halloween Party; reported that firefighter Matt Diaz joined the United States Marine Corps; reminded residents to attend the Veterans Day ceremony; announced that the Village Holiday Tree Lighting is December 7; stated that snow season is coming and summonses will be issued for vehicles left on streets; commented on the November 6 general elections, and stated that the loss of Senator Elaine Phillips is a loss to the Village of Mineola, and wished her well.

Trustee Paul A. Pereira congratulated all election winners and thanked those who lost for their service; discussed the Pittsburgh tragedy and a subsequent unity event at Congregation Beth Sholom Chabad; stated that he attended ribbon cutting ceremonies for Lili's Boutique and JB Vintage; congratulated the Mineola High School Marching Band on winning the State Championship, adding that they will be recognized at next week's Village Board Meeting; reminded residents that Daylight Savings Time ended which is also a reminder to change batteries in smoke detectors, and encouraged residents to attend the Veterans Day ceremony on Sunday November 11 at 11:00 AM.

Trustee Paul S. Cusato commented on the Pittsburgh tragedy; congratulated election winners; thanked all who organized Halloween Party; congratulated the Mineola High School Marching Band on their State Championship; reminded residents to change their smoke detector batteries; discussed the efforts by Mineola Historical Society members, and announced that Toys for Tots collection boxes will be at Village Hall, Mineola Memorial Library and Mineola Fire Department headquarters.
