BOARD OF TRUSTEES INCORPORATED VILLAGE OF MINEOLA

APPOINTMENT OF FIRST BOARD MEMBERS OF THE VILLAGE BOARD OF ASSESSMENT REVIEW, FIXING TERMS OF OFFICE, ESTABLISH A COURSE OF TRAINING, FIXING COMPENSATION AND REQUIRING MEMBERS TO COMPLY WITH THE VILLAGE'S ANNUAL STATEMENT OF FINANCIAL DISCLOSURE

WHEREAS, by Local Law #1 of 2018, the Board of Trustees amended Section 115 of the Municipal Code of the Incorporated Village of Mineola, Section 115-12C, entitled "Board of Assessment Review", to establish a three (3) member Board of Assessment Review pursuant to Real Property Tax Law §523; and

WHEREAS, it is the intent of the Board of Trustees that the Board of Assessment Review shall have all powers and duties set forth in Real Property Tax Law §523; it is therefore

RESOLVED that, pursuant to Real Property Tax Law §523-1(a)-(c), the Board of Trustees hereby appoints the following individuals to the Board of Assessment Review for the initial terms indicated in the parentheses set forth after their names: John Bernardes (for an initial term of three years); Andrew Ward (for an initial term of four years), and Frank Hoare (for an initial term of five years). Thereafter, all members of the Board of Assessment Review shall be appointed for a term of five (5) years. The terms of office of members of the Board of Assessment Review shall commence on the 1st day of October and terminate on the 13th day of September, five (5) years thereafter; and it is further

RESOLVED that, pursuant to Real Property Tax Law §523-1(e), the members of the Board of Assessment Review shall annually choose one of their number to serve as Chairperson of the Board and shall notify the Village Clerk within five days after the person is so designated; and it is further

RESOLVED that, pursuant to Real Property Tax Law §523-1(g), the Board of Trustees

hereby fixes the compensation of members of the Board of Assessment Review at \$200.00 per

meeting; and it is further

RESOLVED that, pursuant to Real Property Tax Law §523-1(h), the Board of Assessment

Review may appoint a secretary who shall perform such confidential duties and such other duties

as are necessary to enable the Board of Assessment Review to properly and efficiently carry out

their duties. The compensation of such secretary shall be fixed by the Board of Trustees; and it is

further

RESOLVED that, pursuant to Real Property Tax Law §523-2, each member of the Board

of Assessment Review shall attend a training course to be conducted by the Village Attorney's

Office each year, on a date convenient for the Board members. The training shall include, but not

be limited to, the functions, duties and responsibilities of the Board of Assessment Review,

assessment review, assessment procedures, exemption administration, real property tax legislation,

judicial decisions, and administrative opinions; and it is further

RESOLVED that, pursuant to Real Property Tax Law §523-3, members of the Board of

Assessment Review shall be required to comply with the Village's Annual Statement of Financial

Disclosure to ensure that no member acts upon any case where he or she has a direct or indirect

interest in any property for which a complaint has been filed.

Mayor Scott P. Strauss discussed the recent snow event, urging residents to shovel corners and hydrants; noted the excellent job done by the Department of Public Works, and encouraged residents to attend the Kiwanis Super Bowl pancake breakfast fundraiser Sunday February 4. Mayor Strauss added that he recently met with the Nassau County Department of Public Works on an unrelated issue, but snow removal was discussed.

Trustee Paul A. Pereira discussed the recent snowstorm and commented on the excellent condition of the Village roads in comparison to Nassau County roads.

Trustee Paul S. Cusato discussed the snow event, and thanked the Department of Public Works, the Mineola Fire Department, and residents, who moved cars and shoveled hydrants; congratulated Nassau County Legislator Rich Nicolello on being elected Presiding Officer, and discussed the snow removal problem on County roads with him at a Chamber of Commerce meeting; reported that the Chamber of Commerce "Taste and Style" fundraiser funds were distributed to local groups, and announced the Kiwanis Super Bowl pancake breakfast fundraiser.

Trustee George R. Durham had no report.

Trustee Dennis J. Walsh also congratulated Rich Nicolello; stated that the 55 new commuter parking spaces are still being underutilized; congratulated incoming Irish American Society President Jeff Clark, and stated that the Irish Consul General is coming to Mineola on January 28 at the Irish American Center.
