Mayor Scott P. Strauss congratulated Mineola Fire Department Ladies Auxiliary members Pat Kessler and Marian Kessler who were honored during the Work Session for their 65 years of service with the organization; commented on recent water quality articles, and stated that the Village follows strict guidelines and our water is safe to drink; thanked American Legion Commander Carl Marchese and all who organized the Memorial Day parade and ceremony, and thanked the Chamber of Commerce for handing out 4,000 American flags to parade watchers; encouraged residents to shop locally; stated that there were two Court of Honor events, and congratulated Troop 200 Eagle Scouts Aidan Coffey, Evan Eberlein, Kyle Eberlein, and Alexander Marchiselli, and Troop 45 Eagle Scouts Matthew Catania, Michael Bereswell, Joseph Bereswell, Ryan Braster, and Derek D'Annunzio; and commented that June 6, 2019 is the 75<sup>th</sup> anniversary of D-Day, and that we should never forget the sacrifices made.

Trustee Paul A. Pereira commented that the length of service by Ladies Auxiliary members Pat Kessler and Marian Kessler is close in length to the anniversary of D-Day, demonstrating that their service to the community is why they are the "Greatest Generation," thanked the organizers of the Memorial Day parade and the Chamber of Commerce for going out of their way to purchase flags that were made in the USA; announced upcoming events, including the Mineola Athletic Association Family Fun Day on Saturday June 8, the first summer concert, *Endless Summer*, a Beach Boys tribute band, on June 22, the Portugal Day Parade on Sunday June 9, and the Mineola Portuguese Feast and Carnival June 7-9, and he gave a brief history of why many Portuguese people settled in Mineola.

Trustee Paul S. Cusato congratulated Troop 45 Eagle Scouts, commenting that he tried scouting briefly and appreciates the hard work and commitment; thanked Carl Marchese and his committee for organizing Memorial Day parade, and the Chamber of Commerce for distributing American flags; stated that Mineola Fire Department members will be going door-to-door for fund drive, and congratulated Trustee Pereira who is the Grand Marshal of the Portugal Day Parade.

Trustee George R. Durham commented that Carl Marchese did a good job organizing the Memorial Day parade and ceremony; congratulated Troop 45 Eagle Scouts Michael Bereswell and Joseph Bereswell who have earned 130 out of 135 merit badges; announced that the Troop 45 Father's Day Pancake Breakfast will be held June 16 from 7:30 am-12:00 pm, and announced that the John S. DaVanzo Community Pool will open June 15.

Trustee Dennis J. Walsh discussed D-Day, focusing on Mineola resident Ray Vaz; stated that the homeless people at the Long Island Railroad station are not helped by online photos and commentary, adding that the problem is bigger than the village, and not solved just with policing. Trustee Walsh provided several resources, including the Long Island Coalition for the Homeless (www.lihomeless.org or 631-464-4314), Nassau County Department of Social Services Homeless Intervention (516-227-8519), and Services for the Underserved (631-227-0777). Trustee Walsh added that the homeless are not animals or criminals, but if criminal activity is witnessed, call 9-1-1.
