Mayor Scott P. Strauss began the meeting by requesting that all present observe a moment of silence for the families of Roger Fay, Lou Sanders, and the Las Vegas shooting victims for their recent losses. Mayor Strauss reported that Mineola TV has not been broadcast for several days, but will be fixed shortly; discussed several parking issues especially for Long Island Rail Road commuters; thanked John Carway for his 20+ years of service to the Village, and reported that John will be retiring from his position on the Zoning Board and will be replaced by Jim Sherry; congratulated Mathew Sanderleaf of the Mineola Fire Department Company 2 who is the recipient of the Town of Hempstead Firematic Award; congratulated Lou Santosus who was selected for the John S. DaVanzo Wall of Honor; stated that there is a new speed sign on Westbury Avenue, and an additional sign will be coming in a different area of the Village; reported that he met with the Third Precinct regarding issues at the Long Island Rail Road station, and reminded residents that October is Breast Cancer Awareness Month. Mayor Strauss added that the Mineola Fire Department is holding an Open House Sunday October 15 from 11:00 am – 2:00 pm, and encouraged residents to attend. Mayor Strauss commented that winter is approaching and reminded residents to move vehicles off street whenever there is more than two inches of snowfall, and not shovel snow into streets.

Pereira discussed the problem of speeding cars, especially around schools, parks, and playgrounds, stating that parents are guilty of this too; announced the "Think Pink" girls soccer game fundraiser on Friday October 6 at Hampton Stadium at 6:30 pm; announced that the Mineola High School homecoming parade is Saturday October 7 at 4:30 pm with the inaugural football game at Hampton Stadium at 6:30 pm; congratulated Lou Santosus on being the Wall of Honor recipient; discussed the Stephen Siller Tunnel to Towers run; and extended condolences to the families of Lou Sanders, Roger Fay, and John Marks of Martins Travel Agency.

Trustee Paul S.
