WHEREAS, in instances where a contractor or property owner believes that a project may be benefited by the use of on-street parking spaces and/or municipal parking field spaces, that contractor or property owner may submit with its building permit application, an application for the Temporary Usage of On-Street Parking Spaces/Municipal Parking Field Spaces During Construction requesting the use of identified parking facilities; and

WHEREAS, the Incorporated Village of Mineola, at its sole discretion, may authorize an applicant to utilize any portion of an on-street parking space and/or municipal parking field space during the construction phase; and

WHEREAS, all applications must be accompanied by the necessary insurance documentation and certificates naming the Incorporated Village of Mineola as an Additional Insured and Certificate Holder, a fully executed Indemnification Agreement running in favor of the Incorporated Village of Mineola and a Restoration Agreement, agreeing to restore the permitted area to its original condition prior to occupation; and

WHEREAS, the non-refundable permit fee for 2023-2024 for Rate No. 1 (On-Street meters located on First Street between Marcellus Road and Third Avenue; Second Street between Third Avenue and Mineola Boulevard, Third Avenue between Station Plaza North and Harrison Avenue) shall be \$20 per day for each on-street parking space with an administrative processing fee of \$10 per application/renewal; and

WHEREAS, the non-refundable permit fee for 2023-2024 for Rate No. 2 (All other On-Street parking meters located within the Incorporated Village of Mineola) shall be \$10 per day for each on-street parking space (excluding the areas designated in Rate No. 1) with an administrative processing fee of \$10 per application/renewal; and

WHEREAS, the non-refundable permit fee for 2023-2024 for Rate No. 3 (All Paid Municipal Parking Lots within the Incorporated Village of Mineola) shall be \$20 per day for each on-street parking space with an administrative processing fee of \$10 per application/renewal; and

WHEREAS, the permit fees aforementioned may be amended from time to time by Resolution of the Board of Trustees;

NOW, THEREFORE, BE IT RESOLVED, that the Incorporated Village of Mineola establishes a Temporary Usage of On-Street Parking Spaces/Municipal Parking Field Spaces For Construction Permit in accordance with the terms and condition provided above. The non-

refundable fee for 2023-2024 for Rate No. 1 shall be \$20 per day per parking space, Rate No. 2 shall be \$10 per day per parking space and Rate No. 3 shall be \$20 per day per parking space, each with an administrative processing fee of \$10 per application/renewal. The fees may be amended from time to time by Resolution by the Board of Trustees.
