#### Resolution No. 166-23

WHEREAS, the Incorporated Village of Mineola has undertaken to design and construct improvements to the Village Water System Facilities at Well No. 1; and

WHEREAS, the work shall include the construction of a new masonry building to house a Granular Activated Carbon (GAC) Absorption Treatment System to meet emerging contaminant treatment recommendations at the Well No. 1 facility (hereinafter referred to as, "the Proposed Action"); and

**WHEREAS,** the Board of Trustees has completed its review pursuant to SEQRA and has completed a Short Environmental Assessment Form to assist it in evaluating the environmental impact of the Proposed Action.

**NOW, THEREFORE, BE IT RESOLVED**, that the design and construction of improvements to the Village Water System Facilities at Well No. 1 is a Type II Action under the SEQRA and the Board finds that it poses no significant environmental impact as that term is defined under SEQRA.

#### Resolution No. 167-23

BOND RESOLUTION OF THE VILLAGE OF MINEOLA, ADOPTED JUNE 7, 2023 AUTHORIZING CONSTRUCTION OF A TREATMENT SYSTEM FOR THE REMOVAL OF PER- AND POLYFLUOROALKYL SUBSTANCES AT THE WELL 1 FACILITY, STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$9,612,000, APPROPRIATING SAID AMOUNT FOR SUCH PURPOSE, AND AUTHORIZING THE ISSUANCE OF BONDS IN THE PRINCIPAL AMOUNT OF NOT TO EXCEED \$9,612,000 TO FINANCE SAID APPROPRIATION

**WHEREAS**, the Village of Mineola is applying for a funding grant issued through the New York State Department of Health's Environmental Facilities Corporation through the Water Infrastructure Improvement Act (WIIA); and

**WHEREAS,** as part of the Grant Application, the Village of Mineola will commit to providing the difference between the total project cost and funds which may be received through the Grant; and

**WHEREAS**, the maximum amount to be funded through Grants is \$5,767,200 (five million seven hundred sixty seven thousand two hundred dollars) and the estimated maximum project cost is \$9,612,000 (nine million and six hundred twelve thousand dollars).

# NOW, THEREFORE BE IT

**RESOLVED**, that the Village of Mineola has the ability to bond up to the full project cost of \$9,612,000 (nine million and six hundred twelve thousand dollars) which shall be reduced by the amount of any and all such grants that may be received in support of the project should the project receive grant funding from the Environmental Facilities Corporation.
