RESOLUTION TO APPLY FOR A NYS DRINKING WATER STATE REVOLVING FUND EMERGING CONTAMINANTS GRANT (DWSRF-EC) AND A WATER INFRASTRUCTURE IMPROVEMENT ACT GRANT (WIIA)

Discussion was held with regards to the NYS Drinking Water State Revolving Fund (DWSRF) through the Bipartisan Infrastructure Law (BIL) NYS Water Infrastructure Improvement Act (WIIA) and the availability of grants for the State's 2023-2024 fiscal year, particularly the current construction projects that would qualify to receive a grant of up to 60% of net eligible project costs for projects addressing emerging contaminants (if a Maximum Contaminant Level has been exceeded) or the lesser of \$5 million or 60 % of net eligible project costs for emerging contaminants projects without an MCL violation and all other drinking water projects.

It is believed that the following project would qualify for funding under this grant:

• PFAS treatment at Well 1; estimated cost of \$9,612,000.00

The Village Board of Trustees were presented the following resolution to authorize the Village to submit grant applications under the NYS Drinking Water State Revolving Fund (DWSRF) and NYS Water Infrastructure Improvement Act (WIIA) for NYS fiscal year 2023-2024:

WHEREAS, the Bipartisan Infrastructure Law of 2019 (BIL) invested \$27 million in 2022 for Emerging Contaminants through the New York State Drinking Water State Revolving Fund (NYS DWSRF) and it is expected that a similar amount will be made available this year for infrastructure projects that combat emerging contaminants (EC), such as PFOA, PFOS.

WHEREAS, the Clean Water Infrastructure Act of 2017 invested \$3 billion in clean and drinking water infrastructure projects and water quality protection projects across the State of New York, and

WHEREAS, \$425 Million of these funds will be made available in 2023-2024 state fiscal year to selected municipalities with infrastructure projects that protect public health and or improve water quality, including infrastructure projects that combat emerging contaminants (EC), such as PFOA, PFOS and 1,4-dioxane with system upgrades and innovative pilot technologies, and

WHEREAS, under this program the Environmental Facilities Corporation, (EFC), will evaluate applications for projects received by the deadline of 5PM on Friday, July 28, 2023, and

WHEREAS, the Board of Trustees of the Incorporated Village of Mineola believes itself to be qualified for NYS DWSRF and/or NYS WIIA Grants, and is willing to carry out all activities described in the grant application, and

WHEREAS, in this action the Incorporated Village of Mineola will upon an award and acceptance of the grant, agree to the terms of the grant;

WHEREAS, one of the requirements under the NYS DWSRF and NYS WIIA grant administered by the NYS Environmental Facility Corporation (EFC) is that the Trustees are required to appoint a Minority Business Officer (MBO) as the official contact person to administer the Minority and Women Owned Business Enterprise (MWBE) and Service-Disabled Veteran-Owned Business (SDVOB) documentation and act as a liaison between the NYS EFC and the prime contractors.

NOW THEREFORE, after discussion and due deliberation, and in consideration of the above recitals, the Board Unanimously:

RESOLVED, that the Board of Trustees of the Incorporated Village of Mineola authorizes the submittal of grant applications for the NYS Drinking Water State Revolving Fund (NYS DWSRF) and/or NYS Water Infrastructure Improvement Act (WIIA) and assigns Superintendent of Public Works Thomas Rini to be the Authorized Representative of the Village, it was

FURTHER RESOLVED that the Incorporated Village of Mineola requests the funds and assistance available from the NYS DWSRF and/or NYS WIIA Grant and will comply with all rules and requirements of this program, it was

FURTHER RESOLVED that the Board of Trustees Appoint Water Department Supervisor James Martin as the Village's MBO Officer for any NYS DWSRF or WIIA Grant received.

WHEREAS, to facilitate an efficient Grant application process, and in order to comply with the requirements to have an "Authorized Representative," it is recommended that the Superintendent of Public Works for the Incorporated Village of Mineola be granted the authority to sign Grant applications and related documents relating to the New York State Department of Health's Environmental Facilities Corporation Grants and Water Infrastructure Improvement Act (WIIA) Funding;
